A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

10 may be necessary and remains unexpended at the close of business
11 on June 30, 2024, from an appropriation heretofore made for
12 such purpose in Article 79, Section 190 of Public Act 103-0006,
13 as amended, is reappropriated from the U.S. Environmental
14 Protection Fund to the Environmental Protection Agency for
15 enforcement of actions under the Gulf Hypoxia Action Plan
16 pursuant to the Infrastructure Investment and Jobs Act (IIJA).
