WHEREAS, Frank Albanese was born to Peter and Paula Albanese in Springfield on October 8, 1965; he attended Little Flower Grade School and graduated from Griffin High School in 1983; he earned his Bachelor of Arts in Economics and Finance from DePaul University in Chicago in 1988, where he was a member of the Debate Team; over the years, he also completed various continuing education courses from Cornell University's Hospitality Management program; and

WHEREAS, Frank Albanese's passion was the stock market, working in the markets for over 30 years; he began his career working for the Mercantile Exchange in Chicago, and he subsequently worked as a broker for such firms as Merrill Lynch and Lehman Brothers; after returning to Springfield, he worked for the Albanese Development Corporation and founded the ATIA Wealth Management Group, which provides investment advisory services; he completed his career as the principal and chief investment officer of ATIA; he held the series 7, 24, 63, and 66 securities licenses, and he was also a licensed insurance agent; he also continued his side project,
