- 4 Section 5. The Department of Veterans Affairs Act is

- 9 Sec. 509. Tax checkoff explanations. All individual
- 10 income tax return forms shall contain appropriate
- 11 explanations and spaces to enable the taxpayers to designate
- 12 contributions to the following funds: the Child Abuse
- 13 Prevention Fund, to the Illinois Wildlife Preservation Fund
- 14 (as required by the Illinois Non-Game Wildlife Protection
- 15 Act), to the Alzheimer's Disease Research Fund (as required
- 16 by the Alzheimer's Disease Research Act), to the Assistance
- to the Homeless Fund (as required by this Act), to the Penny
- 18 Severns Breast and Cervical Cancer Research Fund, to the
