- of the Illinois Credit Card and Debit Card Act.
- 20 "Provider" means a person who furnishes money, goods,
- 21 <u>services</u>, or <u>anything else</u> of <u>value upon presentation</u>,
- 22 <u>whether physically, in writing, verbally, electronically, or</u>

- 1 <u>otherwise</u>, of a credit card or debit card by the cardholder,
- or any agent or employee of that person.
