developing the skills and strategies necessary for 1 2 instructional excellence, provided that funding is made available by the State Board of Education from an 3 4 appropriation made for this purpose. A public school that has an existing induction and mentoring program that does not 5 meet the requirements set forth in Section 21A-20 of this 6 7 Code may have school years 2003-2004 and 2004-2005 to develop 8 a program that does meet those requirements and may receive 9 funding as described in Section 21A-25 of this Code, provided that the funding is made available by the State Board of 10 Education from an appropriation made for this purpose. A 11 public school with such an existing induction and mentoring 12 program may receive funding for the 2005-2006 school year for 13 each new teacher in the second year of a 2-year program that 14 15 does not meet the requirements set forth in Section 21A-20, 16 as long as the public school has established the required new program by the beginning of that school year as described in 17 Section 21A-15 and provided that funding is made available by 18 the State Board of Education from an appropriation made for 19 this purpose as described in Section 21A-25. 20

Notwithstanding any other provisions of this Code, by the beginning of the 2004-2005 school year (or by the beginning of the 2005-2006 school year for a public school that has been given an extension of time to develop a program under Section 21A-10 of this Code), each public school or 2 or more public schools acting jointly shall establish and implement, in conjunction with its exclusive representative or their exclusive representatives, if any, the new teacher induction and mentoring program required to be developed under Section 21A-10 of this Code, provided that funding is made available by the State Board of Education,

- process of transition to a program that meets those 6
- requirements, the State Board of Education shall pay the 7
