2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 2543 by replacing  
3 everything after the enacting clause with the following:

4 "Section 5. The following named amounts, or so much of  
5 those amounts as may be necessary, respectively, for the  
6 objects and purposes named, are appropriated from the General  
7 Revenue Fund to the Office of the State Appellate Defender to  
8 meet its ordinary and contingent expenses.

20 Section 15. The following named amounts, or so much of  
 21 those amounts as may be necessary, respectively, for the  
 22 objects and purposes names, are appropriated to the Office of  
 23 the State Appellate Defender for expenses related to  
 24 federally assisted programs to work on systemic sentencing  
 25 issues appeals cases to which the agency is appointed,  
 26 provide statewide training and services to Illinois Public  
 27 Defenders, and to enhance the capability of public defenders  
 28 in rural counties to effectively represent their clients in  
 29 appropriate cases, making available to them expert witnesses  
 30 and investigative services.

1 Payable from State Appellate  
 2 Defender Federal Trust Fund .....700,000  
 3 For State matching purposes:  
 4 Payable from Special State Projects Fund .....225,000

5 Section 20. The amount of \$3,133,476, or so much of that  
 6 amount as may be necessary, is appropriated from the Capital  
 7 Litigation Trust Fund to the Office of the State Appellate  
 8 Defender for expenses incurred in providing assistance to  
 9 trial attorneys under item (c) (5) of Section 10 of the State  
 10 Appellate Defender Act.

11 Section 25. The amount of \$157,000, or so much of that  
 12 amount as may be necessary, is appropriated from the General  
 13 Revenue Fund to the Office of the State Appellate Defender  
 14 for the ordinary and contingent expenses of the Expungement  
 15 Program.

16 Section 99. Effective date. This Act takes effect July  
 17 1, 2004."
