Amend Senate Bill 2880, AS AMENDED, 3 with reference to page and line numbers of House Amendment No. 1, on page 5, by replacing lines 13 through 27 with the 4 5 following: "(e) Moneys appropriated by the General Assembly for the 6 7 purpose of this Section, receipts from donations, grants, fees, or taxes that may accrue from any public or private sources to the Department for the purpose of this Section, and savings 9 10 attributable to the nursing home conversion program as calculated in subsection (h) shall be deposited into the 11 Department on Aging State Projects Fund.
