Makes appropriations to the Court of Claims for the purpose of making awards. Effective July 1, 2004.

**A BILL FOR**

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 1. The following named amounts are appropriated  
5 from the General Revenue Fund to the Court of Claims to pay  
6 claims in conformity with awards and recommendations made by  
7 the Court of Claims as follows:

8 No. 96-CC-4265, Judith Herrmann. Tort, against the  
9 Department of Public Health. ....\$71,789.55

10 No. 98-CC-3134, Anne Wos. Personal Injury, against the  
11 Secretary of State. ....\$5,850.00

12 No. 00-CC-2010, Danny Montley. Personal Injury, against  
13 the Department of Corrections. ....\$43,724.58

14 No. 00-CC-4663, Jonathon W. Kefer. Reimbursement, against  
15 the Department of Transportation. ....\$14,425.74

17 Chicago State University. ....\$60,000.00

18 Section 2. The following named amounts are appropriated
