Makes appropriations and reappropriations to the Board of Trustees of Eastern Illinois University for various purposes, including ordinary and contingent expenses. Effective July 1, 2004.

A BILL FOR

1 AN ACT making appropriations and reappropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much
5 thereof as may be necessary, respectively, for the purposes
6 hereinafter named, are appropriated from the General Revenue
7 Fund to the Board of Trustees of Eastern Illinois University
8 to meet the ordinary and contingent expenses of the
9 University, including payment or reimbursement to the
10 University for personal services and related costs incurred
11 during the fiscal year ending June 30, 2005 and for personal
12 services and related costs accrued during fiscal year 2004
13 but remaining unpaid on June 30, 2004:

15	Contractual Services	1,700,000
16	Commodities	500,000

20 Section 10. The sum of \$185,946, or so much thereof as
21 may be necessary and remains unexpended at the close of
22 business on June 30, 2004, from a reappropriation heretofore
23 made for such purpose in Article 9, Section 10 of Public Act
24 93-90, is reappropriated from the Capital Development Fund to
25 the Board of Trustees of Eastern Illinois University for
26 digitalization infrastructure for WEIU-TV. No contract shall
27 be entered into or obligation incurred for any expenditure
28 from the appropriation made in this Section until after the
29 purposes and amounts have been approved in writing by the
30 Governor.

1 Section 15. The sum of \$100,000, or so much thereof as
2 may be necessary and remains unexpended at the close of
3 business on June 30, 2004, from a reappropriation heretofore
4 made for such purpose in Article 9, Section 15 of Public Act
5 93-90, is reappropriated from the Capital Development Fund to
6 the Board of Trustees of Eastern Illinois University for
7 digitalization infrastructure for WEIU-TV, in addition to
8 amounts otherwise appropriated for such purpose. No contract
9 shall be entered into or obligation incurred for any
10 expenditure from the appropriation made in this Section until
11 after the purposes and amounts have been approved in writing
12 by the Governor.

13 Section 20. The sum of \$393,294, or so much thereof as
14 may be necessary and remains unexpended at the close of
15 business on June 30, 2004, from a reappropriation heretofore
16 made for such purpose in Article 9, Section 20 of Public Act
17 93-90, is reappropriated from the Capital Development Fund to
18 the Board of Trustees of Eastern Illinois University to
19 purchase equipment for the renovation and expansion of Booth
20 Library. No contract shall be entered into or obligation
21 incurred for any expenditure from the appropriation made in
22 this Section until after the purposes and amounts have been
23 approved in writing by the Governor.

24 Section 25. The sum of \$5,430,400, or so much thereof as
25 may be necessary and remains unexpended at the close of
26 business on June 30, 2004, from a reappropriation heretofore
27 made for such purpose in Article 9, Section 25 of Public Act
28 93-90, is reappropriated from the Capital Development Fund to
29 the Board of Trustees of Eastern Illinois University to
30 purchase equipment for the renovation and expansion of the
31 Fine Arts Center. No contract shall be entered into or
32 obligation incurred for any expenditure from the

1 appropriation made in this Section until after the purposes
2 and amounts have been approved in writing by the Governor.

3 Section 30. The sum of \$1,500,000, or so much thereof as
4 may be necessary, is appropriated from the Capital
5 Development Fund to the Board of Trustees of Eastern Illinois
6 University to purchase equipment for the renovation and
7 expansion of the Fine Arts Center. No contract shall be
8 entered into or obligation incurred for any expenditure from
9 the appropriation made in this Section until after the
10 purposes and amounts have been approved in writing by the
11 Governor.

12 Section 35. The sum of \$2,000, or so much thereof as may
13 be necessary, is appropriated from the State College and
14 University Trust Fund to the Board of Trustees of Eastern
15 Illinois University for scholarship grant awards, in
16 accordance with Public Act 91-83. No contract shall be
17 entered into or obligation incurred for any expenditure from
18 the appropriation made in this Section until after the
19 purposes and amounts have been approved in writing by the
20 Governor.

21 Section 99. Effective date. This Act takes effect July 1,
22 2004.
