1 AN ACT concerning local government.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Municipal Code is amended by changing Section 11-55-2 as follows:
- 6 (65 ILCS 5/11-55-2) (from Ch. 24, par. 11-55-2)
- 7 Sec. 11-55-2. No municipality with a population of less than 1,000,000, including a home rule unit, may increase the 8 9 fee for a license to own or operate a vending machine or to 10 dispense goods or services therefrom unless notice of a public hearing on the matter has been given and such hearing has been 11 12 held. The amount of the increase shall not exceed the greater of the amount of the fee multiplied by: (i) 5% or (ii) the 13 percentage increase in the Consumer Price Index for All Urban 14 15 Consumers for all items published by the United States Department of Labor during the 12-month calendar year preceding 16 17 the year in which the fee is increased. Notice of the proposed increase shall be mailed at least 30 days before the hearing to 18 19 the last known address of each person currently holding such a 20 license. It is declared to be the law of this State, pursuant to paragraph (g) of Section 6 of Article VII of the Illinois 21 22 Constitution, that this <u>Section</u> amendatory Act of 1986 is a denial of the power of certain home rule units to increase 23 vending machine license fees without complying with the 24 25 requirements of this Section.
