

94TH GENERAL ASSEMBLY State of Illinois 2005 and 2006 HB1093

SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.640 new 625 ILCS 5/3-663 new

Amends the Illinois Vehicle Code and the State Finance Act. Creates the Illinois Illinois Professional Golfers Association Foundation Junior Golf Fund as a special fund in the State treasury. Provides for the issuance of Illinois Professional Golfers Association Foundation Junior Golf license plates. Provides that in addition to the appropriate registration fees, an applicant for the special plate shall be charged a fee of \$40 at original issuance and at renewal. Provides that \$25 of the additional original issuance fee and \$38 of the renewal fee shall be deposited into the Illinois Professional Golfers Association Foundation Junior Golf Fund. Provides that \$15 of the original issuance fee and \$2 of the renewal fee shall be deposited into the Secretary of State Special License Plate Fund. Provides that, subject to appropriation by the General Assembly and approval by the Secretary of State, the moneys in the Illinois Professional Golfers Association Foundation Junior Golf Fund shall be paid as grants to the Illinois Professional Golfers Association Foundation to help Association members expose Illinois youngsters to the game of golf. Effective immediately.

1 AN ACT regarding transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The State Finance Act is amended by adding
- 5 Section 5.640 as follows:

- 7 Sec. 5.640. The Illinois Professional Golfers Association
- 8 <u>Foundation Junior Golf Fund.</u>
- 9 Section 10. The Illinois Vehicle Code is amended by adding
- 10 Section 3-663 as follows:

- 12 <u>Sec. 3-663. Illinois Professional Golfers Association</u>
- 13 <u>Foundation Junior Golf license plates.</u>
- 14 <u>(a) The Secretary, upon receipt of all applicable fees and</u>
- applications made in the form prescribed by the Secretary, may
- 16 <u>issue special registration plates designated as Illinois</u>
- 17 Professional Golfers Association Foundation Junior Golf
- 18 license plates.
- The special plates issued under this Section shall be
- 20 affixed only to passenger vehicles of the first division or
- 21 motor vehicles of the second division weighing not more than
- 22 <u>8,000 pounds</u>.
- 23 Plates issued under this Section shall expire according to
- 24 <u>the multi-year procedure established by Section 3-414.1 of this</u>
- 25 Code.
- 26 (b) The design and color of the special plates shall be
- 27 wholly within the discretion of the Secretary. Appropriate
- documentation, as determined by the Secretary, shall accompany
- 29 each application.
- 30 (c) An applicant for the special plate shall be charged a

- 2 registration fee. Of this fee, \$25 shall be deposited into the
- 3 <u>Illinois Professional Golfers Association Foundation Junior</u>
- 4 Golf Fund and \$15 shall be deposited into the Secretary of
- 5 State Special License Plate Fund, to be used by the Secretary
- 6 to help defray the administrative processing costs.
- For each registration renewal period, a \$40 fee, in
- 8 <u>addition to the appropriate registration fee, shall be charged.</u>
- 9 Of this fee, \$38 shall be deposited into the Illinois
- 10 Professional Golfers Association Foundation Junior Golf Fund
- and \$2 shall be deposited into the Secretary of State Special
- 12 <u>License Plate Fund.</u>
- 13 (d) The Illinois Professional Golfers Association
- 14 <u>Foundation Junior Golf Fund is created as a special fund in the</u>
- 15 <u>State treasury. All moneys in the Illinois Professional Golfers</u>
- 16 <u>Association Foundation Junior Golf Fund shall be paid, subject</u>
- 17 <u>to appropriation by the General Assembly and approval by the</u>
- 18 Secretary, as grants to the Illinois Professional Golfers
- 19 Association Foundation to help Association members expose
- 20 <u>Illinois youngsters to the game of golf.</u>
- 21 Section 99. Effective date. This Act takes effect upon
- 22 becoming law.
