2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Election Code is amended by changing 5 Sections 19-1, 19-2, 19-3, and 19-5 as follows:

Any qualified elector of the State of Illinois 8 having duly registered where such registration is required who is of the age of 65 or more years or who expects to be absent 9 from the county in which he is a qualified elector or who 10 because of being appointed a judge of election in a precinct 11 other than the precinct in which he resides or who because of 12 physical incapacity or the tenets of his religion in the 13 14 observance of a religious holiday or who because of election 15 duties for the office of an Election Authority or the State Board of Elections or who because of election duties for a law 16 17 enforcement agency, including but not limited to the offices of the Attorney General, a State's Attorney, a United States 18 Attorney, or a State, county, or municipal police department, 19 or who, because he is temporarily abiding outside the precinct 20 in which he is registered to vote due to the fact he is a 21 22 student attending an institution of higher education or who is 23 serving as a sequestered juror on a State or federal jury, will be unable to be present at the polls on the day of holding any 24 25 special, general or primary election at which any presidential 26 preference is indicated or any candidates are chosen or elected, for any congressional, State, district, county, town, 27 28 city, village, precinct or judicial offices or at which questions of public policy are submitted, may vote at such 29 30 election as hereinafter in this Article provided.

of his or its officers or employees who are eligible to vote
 under this Article by reason of election duties.

For purposes of this Article 19, a physically incapacitated voter marks his or her ballot "personally" when the voter exercises his or her physical abilities to their reasonable limit in marking the ballot, and marking personally may include instructing the person assisting the incapacitated voter when giving such instruction represents the reasonable limit of the physical abilities.

Such instructions shall include the following statement: "In signing the certification on the absentee ballot 14 15 envelope, you are attesting that you personally marked this 16 absentee ballot in secret. If you are physically unable to mark 17 the ballot, a friend or relative may assist you after completing the enclosed affidavit. Federal and State laws 18 19 prohibit a candidate whose name appears on the ballot (unless 20 you are the spouse or a parent, child, brother, or sister of the candidate), your employer, your employer's agent or an 21 22 officer or agent of your union from assisting physically 23 disabled voters."

24 In addition to the above, if a ballot to be provided to an elector pursuant to this Section contains a public question 25 26 described in subsection (b) of Section 28-6 and the territory 27 concerning which the question is to be submitted is not 28 described on the ballot due to the space limitations of such 29 ballot, the election authority shall provide a printed copy of 30 a notice of the public question, which shall include a 31 description of the territory in the manner required by Section 32 16-7. The notice shall be furnished to the elector at the same time the ballot is delivered to the elector. 33
