SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-806

from Ch. 95 1/2, par. 3-806

Amends the Illinois Vehicle Code. Beginning with the 2007 registration year, increases by \$1 the fee to be collected for registration of any vehicle of the first division and any vehicle of the second division weighing 8,000 pounds or less. Provides that the additional \$1 shall be deposited into the State Police Vehicle Fund. Effective immediately.
