28	Preparedness Administrative Fund for Terrorism Task Force
29	Approved Purchases for Homeland Security.
30	Section 40. The sum of \$4,000,000, or so much thereof as
31	may be necessary, is appropriated from the Federal Civil
32	Preparedness Administrative Fund to the Department of State
