15 Whenever it becomes necessary for the State or any
 16 governmental unit to furnish in a disaster area emergency
 17 services directly related to or required by a disaster and
 18 existing funds are insufficient to provide such services, the
 19 Governor may, when he considers such action in the best
 20 interest of the State, release funds from the General Revenue
 21 disaster relief appropriation in order to provide such
 22 services or to reimburse local governmental bodies furnishing
 23 such services. Such appropriation may be used for payment of
 24 the Illinois National Guard when called to active duty in
 25 case of disaster, and for the emergency purchase or renting
 26 of equipment and commodities. Such appropriation shall be
 27 used for emergency services and relief to the disaster area
 28 as a whole and shall not be used to provide private relief to
 29 persons sustaining property damages or personal injury as a
 30 result of a disaster.

19 Section 45. The sum of \$1,257,600, or so much thereof as
20 may be necessary, is appropriated from the Radiation
21 Protection Fund to the Illinois Emergency Management Agency
22 for licensing facilities where radioactive uranium and
23 thorium mill tailings are generated or located, and related
24 costs for regulating the decontamination and decommissioning
25 of such facilities and for identification, decontamination
26 and environmental monitoring of unlicensed properties
27 contaminated with such radioactive mill tailings.

28 Section 50. The sum of \$150,000, or so much thereof as
29 may be necessary, is appropriated from the Radiation
30 Protection Fund to the Illinois Emergency Management Agency
31 to conduct studies, investigations, training, research and
32 demonstrations relating to the control or measurement of

1 radiation, the effects on health of exposure to radiation,
2 and related problems under funding agreements with the
3 Federal Government, interstate agencies or other sources.

4

5 Section 55. The sum of \$713,700, or so much thereof as
6 may be necessary, is appropriated from the Radiation
7 Protection Fund to the Illinois Emergency Management Agency
8 for the purpose of funding costs related to environmental
9 cleanup of the Ottawa Radiation Areas Superfund Project under
10 cooperative agreements with the Federal Government.

11

12 Section 60. The sum of \$250,000, or so much thereof as
13 may be necessary, is appropriated from the Radiation
14 Protection Fund to the Illinois Emergency Management Agency
15 for recovery and remediation of radioactive materials and
16 contaminated facilities or properties when such expenses
17 cannot be paid by a responsible person or an available
18 surety.

19 Section 65. The sum of \$100,000, or so much thereof as
20 may be necessary, is appropriated from the Nuclear Safety
21 Emergency Preparedness Fund to the Illinois Emergency
22 Management Agency for related training and travel expenses
23 and to reimburse the Illinois State Police and the Illinois
24 Commerce Commission for costs incurred for activities related
25 to inspecting and escorting shipments of spent nuclear fuel,
26 high-level radioactive waste, and transuranic waste in
27 Illinois as provided under the rules of the Agency.

28 Section 70. The sum of \$180,000, or so much thereof as
29 may be necessary, is appropriated from the Sheffield Agreed
30 Order Fund to the Illinois Emergency Management Agency for
31 the care, maintenance, monitoring, testing, remediation and
32 insurance of the low-level radioactive waste disposal site

1 near Sheffield, Illinois.

2 Section 75. The sum of \$766,600, or so much thereof as
3 may be necessary, is appropriated from the Low-Level
4 Radioactive Waste Facility Development and Operation Fund to
5 the Illinois Emergency Management Agency for use in
6 accordance with Section 14(a) of the Illinois Low-Level
7 Radioactive Waste Management Act for costs related to
8 establishing a low-level radioactive waste disposal facility.

9 Section 99. Effective date. This Act takes effect July 1,
10 2005.
