AN ACT concerning title insurance.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Title Insurance Act is amended by changing
Sections 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 14.1, 15,
16, 17, 18, 19, 20, 21, 22, 23, 24, and 25 and by adding
Sections 4.1, 21.1, 21.2, and 21.3 as follows:

Sec. 2. Any corporation which has been or shall be 9 incorporated or qualified to do business under the Business 10 Corporation Act of 1983, as now or hereafter amended, or any 11 predecessor law for the purpose, in whole or part, of doing the 12 business of title insurance guaranteeing or insuring titles to 13 14 real estate, may transact such business during the time for 15 which it may be incorporated or qualified to do business in this State, subject to the requirements of this Act. 16 17 (Source: P.A. 86-239.)

19 (D) Guaranteeing or warranting the status of title as 20 to ownership of or liens on real property and personal 21 property by any person other than the principals to the 22 transaction; or

(E) Doing or proposing to do any business substantially equivalent to any of the activities listed in this subsection, provided that the preparation of an attorney's opinion of title pursuant to paragraph (1)(C) is not intended to be within the definition of "title insurance business" or "business of title insurance".

(1.5) "Title insurance" means insuring, guaranteeing, 29 30 warranting, or indemnifying owners of real or personal property 31 or the holders of liens or encumbrances thereon or others 32 interested therein against loss or damage suffered by reason of liens, encumbrances upon, defects in, or the unmarketability of 33 34 the title to the property; the invalidity or unenforceability of any liens or encumbrances thereon; or doing any business in 35 substance equivalent to any of the foregoing. "Warranting" for 36

purpose of this provision shall not include any warranty contained in instruments of encumbrance or conveyance. <u>Title</u> <u>insurance is a single line form of insurance, also known as</u> <u>monoline.</u> An attorney's opinion of title pursuant to paragraph (1)(C) is not intended to be within the definition of "title insurance".

(2) "Title insurance company" means any domestic company 7 8 organized under the laws of this State for the purpose of conducting the business of title insurance guaranteeing or 9 10 insuring titles to real estate and any title insurance company 11 organized under the laws of another State, the District of 12 Columbia or foreign government and authorized to transact the 13 business of title insurance guaranteeing insuring + + + 1 0 3 or real estate in this State. 14

15 "Title insurance agent" means a person, (3) firm, 16 partnership, association, corporation or other legal entity 17 registered by a title insurance company and authorized by such company to determine insurability of title in accordance with 18 19 generally acceptable underwriting rules and standards in 20 reliance on either the public records or a search package prepared from a title plant, or both, and authorized in 21 22 addition to do any of the following: act as an escrow agent, 23 solicit title insurance, collect premiums, issue title 24 reports, binders or commitments to insure and policies in its 25 behalf, provided, however, the term "title insurance agent" 26 shall not include officers and salaried employees of any title 27 insurance company.

(4) "Producer of title business" is any person, firm, 28 29 partnership, association, corporation or other legal entity 30 engaged in this State in the trade, business, occupation or profession of (i) buying or selling interests in real property, 31 32 (ii) making loans secured by interests in real property, or 33 (iii) acting as broker, agent, attorney, or representative of natural persons or other legal entities that buy or sell 34 35 interests in real property or that lend money with such 36 interests as security.

1 (5) "Associate" is any firm, association, partnership, 2 corporation or other legal entity organized for profit in which 3 a producer of title business is a director, officer, or partner 4 thereof, or owner of a financial interest, as defined herein, 5 in such entity; any legal entity that controls, is controlled 6 by, or is under common control with a producer of title business; and any natural person or legal entity with whom a 7 8 producer of title business has any agreement, arrangement, or 9 understanding or pursues any course of conduct the purpose of which is to evade the provisions of this Act. 10

(6) "Financial interest" is any ownership interest, legalor beneficial, except ownership of publicly traded stock.

13 (7) "Refer" means to place or cause to be placed, or to 14 exercise any power or influence over the placing of title 15 business, whether or not the consent or approval of any other 16 person is sought or obtained with respect to the referral.

17 (8) "Escrow Agent" means any title insurance company or any title insurance agent, including independent contractors of 18 19 either, acting on behalf of a title insurance company which 20 receives deposits, in trust, of funds or documents, or both, for the purpose of effecting the sale, transfer, encumbrance or 21 22 lease of real property to be held by such escrow agent until 23 title to the real property that is the subject of the escrow is 24 in a prescribed condition. An escrow agent conducting closings shall be subject to the provisions of paragraphs (1) through 25 (4) of subsection (e) of Section 16 of this Act. 26

27 (9) "Independent Escrowee" means any firm, person, 28 partnership, association, corporation or other legal entity, other than a title insurance company or a title insurance 29 30 agent, which receives deposits, in trust, of funds or documents, or both, for the purpose of effecting the sale, 31 32 transfer, encumbrance or lease of real property to be held by 33 such escrowee until title to the real property that is the subject of the escrow is in a prescribed condition. Federal and 34 35 State chartered banks, savings and loan associations, credit unions, mortgage bankers, banks or trust companies authorized 36

to do business under the Illinois Corporate Fiduciary Act, 1 2 licensees under the Consumer Installment Loan Act, real estate 3 brokers licensed pursuant to the Real Estate License Act of 4 2000, as such Acts are now or hereafter amended, and licensed 5 attorneys when engaged in the attorney-client relationship are 6 exempt from the escrow provisions of this Act. <u>"Independent</u> 7 Escrowee" does not include employees or independent contractors of a title insurance company or title insurance 8 9 agent authorized by a title insurance company to perform closing, escrow, or settlement services. 10

(10) "Single risk" means the insured amount of any title 11 insurance policy, except that where 2 or more title insurance 12 13 policies are issued simultaneously covering different estates in the same real property, "single risk" means the sum of the 14 insured amounts of all such title insurance policies. Any title 15 16 insurance policy insuring a mortgage interest, a claim payment 17 under which reduces the insured amount of a fee or leasehold title insurance policy, shall be excluded in computing the 18 19 amount of a single risk to the extent that the insured amount 20 of the mortgage title insurance policy does not exceed the insured amount of the fee or leasehold title insurance policy. 21

(11) "Department" means the Department of Financial <u>and</u>
 <u>Professional Regulation</u> Institutions.

(12) <u>"Secretary"</u> "Director" means the <u>Secretary</u> Director
 of Financial <u>and Professional Regulation</u> Institutions.

26 "Insured closing letter" or "closing protection (13)27 letter" means an indemnification or undertaking to a party to a 28 real estate transaction, from a principal such as a title insurance company or similar entity, setting forth in writing 29 30 the extent of the principal's responsibility for intentional 31 misconduct or errors in closing the real estate transaction on the part of a settlement agent, such as a title insurance agent 32 or other settlement service provider. 33

Sec. 4. <u>Deposits.</u>

(a) Before doing business in the State of Illinois, a Every 3 4 title insurance company <u>must file with and have approved by the</u> 5 Secretary cash or licensed or qualified to do business in this 6 State shall, within 30 days after the effective date of this Act or within 30 days after incorporated or licensed to do 7 business, whichever is later, deposit with the Department, for 8 9 the benefit of the creditors of the company by reason of any 10 policy issued by it, bonds of the United States, this State or 11 any body politic of this State in amounts as specified in 12 subsection (b). The deposit is not to be otherwise pledged or 13 subject to distribution among creditors or stockholders until all claims of escrow depositors, claims of policyholders, and 14 15 claims under reinsurance contracts have been paid in full or 16 discharged, reinsured, or otherwise assumed by a title 17 insurance company authorized to do business under this Act. The cash, bonds, and securities so deposited may be exchanged for 18 19 other such securities. No such cash, bond, or security shall be 20 sold or transferred by the <u>Secretary</u> Director except on order of the circuit court or as provided in subsection (d). As long 21 as the company depositing such securities remains solvent, the 22 23 company shall be permitted to receive from the Secretary Director the interest on such deposit. 24

(b) The deposit required under subsection (a) must have a 25 then current value of \$1,000,000. All deposits shall be held 26 27 for the benefit of any insured under a policy the title insurance company issued or named party to a written escrow it 28 accepted. The deposit is not to be otherwise pledged or subject 29 to distribution among creditors or stockholders. Every title 30 31 insurance company shall deposit bonds or securities in the sum of \$50,000 plus \$5,000 for each county, more than one, in which 32 the real estate, upon which such policies are issued, is 33 located, to maximum deposit of \$500,000. Every title insurance 34 or insuring titles -real 35 mpany quaranteeing counties having 500,000 or more inhabitants shall 36 deposit

1 securities with the Department in the sum of \$500,000. Any 2 title insurance company having deposited \$500,000 in 3 securities with the Department shall be entitled to guarantee 4 or insure titles in any or all counties of the State.

5 (c) The <u>Secretary</u> Director may provide for custody of <u>the</u> 6 deposits such securities by any trust company or bank located in this State and qualified to do business under the Corporate 7 8 Fiduciary Act, as now or hereafter amended. The compensation, 9 if any, of such custodian shall be paid by the depositing company. When the required deposits deposit have has been made 10 11 by a title insurance company, the <u>Secretary</u> Director shall 12 certify that the company it has complied with the provisions of 13 this Section and is authorized to transact the business of 14 insuring and guaranteeing titles to real estate.

(d) If, at any time, a title insurance company causes shall 15 16 at any time cause all of its unexpired policies, escrow 17 deposits, and reinsurance obligations in Illinois to be paid in full, cancelled, discharged, or reinsured, or otherwise 18 assumed by another title insurance company and all of its 19 liabilities under such policies thereby to be extinguished, or 20 21 to be assumed by some surety or other responsible company authorized to do business under this Act in this State, the 22 23 Secretary Director shall, upon on application of the such company, verified by the oath of its president or secretary and 24 25 on being satisfied by an examination of its books and its 26 officers under oath that all of its policies are so paid in 27 full, cancelled, discharged, extinguished or reinsured, or otherwise assumed, authorize the release of any bond or deposit 28 posted under this Section. deliver up to it such securities. 29

30 <u>(e) The Secretary may revoke the certificate of authority</u> 31 <u>of a company that fails to maintain the deposit required by</u> 32 <u>this Section. The Secretary shall give notice of that</u> 33 <u>revocation to the company as provided by this Act, and during</u> 34 <u>the time of the revocation, the company may not conduct a title</u> 35 <u>insurance business. have already been assumed. However, it may not solicit new business, complete new searches or examinations, or close transactions. A revocation shall not be set aside until a good and sufficient deposit has been filed with the Secretary and the company is otherwise in compliance with this Act.

If any company shall fail to maintain 24 25 a deposit as required by this Act, the Director may revoke 26 certificate of authority granted on behalf of such company. The 27 Director shall mail a copy of that revocation to the company 28 and during the time of such revocation the company shall not 29 conduct such business. A revocation shall not be set aside 30 until a good and sufficient deposit shall have been made with the Department, fulfilling all the requirements of this Act. 31

2 <u>(a)</u> A title insurance company may obtain reinsurance for 3 all or any part of its liability under one or more of its title 4 insurance policies or reinsurance agreements and may also 5 reinsure title insurance policies issued by other title 6 insurance companies on risks located in this State or 7 elsewhere.

8 (b) A title insurance company licensed to do business in 9 this State shall retain at least \$100,000 of primary liability 10 for policies it issues, unless a lesser sum is authorized by 11 the Secretary. A lesser sum may be retained at the request of 12 an insured for a particular policy. This subsection (b) applies 13 only to policies issued on or after the effective date of this 14 amendatory Act of the 94th General Assembly.

18 (a) Subject to the specific provisions of this Section, the 19 Secretary Director may, after a notice and hearing, order a domestic title insurance company to limit or withdraw from 20 certain investments, or discontinue certain 21 investment 22 practices, to the extent the <u>Secretary</u> Director finds that such 23 investments or investment practices endanger the solvency of 24 the company. The Secretary Director may consider the general 25 investment provisions of the Illinois Insurance Code, as now or 26 hereafter amended, in exercising the authority granted under 27 this subsection (a).

(b) A domestic title insurance company may invest in title 28 29 plants. For determination of the financial condition of such title insurance company, a title plant shall be treated as an 30 31 asset valued at actual cost except that the combined value of all title plants owned shall be limited for asset valuation 32 purposes to 50% of the surplus as regards policyholders as 33 shown on the most recent annual statement of the title 34 35 insurance company.

(d) Amounts placed in the statutory premium reserve in any year in accordance with this Section shall be deducted in determining the net profit of the title insurance company for that year.

in any pending action or proceeding shall be tolled for a period of 6 months after the appointment of a receiver, and no judgment, lien, levy, attachment, or other similar legal process shall be enforced upon or satisfied, in whole or in part, from any asset of the insured or escrow depositor while it is in the possession of the receiver.

(i) If the Secretary determines at any time that no 7 reasonable possibility exists for the title insurance company 8 to be operated by its board of directors in accordance with the 9 provisions of this Act after reasonable efforts have been made 10 11 and that it should be liquidated through receivership, he or 12 she shall appoint a receiver. The Secretary may require of the receiver such bond and security as the Secretary deems proper. 13 The Secretary, represented by the Attorney General, shall file 14 a complaint for the dissolution or winding up of the affairs of 15 16 the title insurance company in a court of the county in which the principal office of the title insurance company is located 17 and shall cause notice to be given in a newspaper of general 18 circulation once each week for 4 consecutive weeks so that 19 20 persons who may have claims against the title insurance company may present them to the receiver and make legal proof thereof 21 and notifying those persons and all to whom it may concern of 22 the filing of a complaint for the dissolution or winding up of 23 the affairs of the title insurance company and stating the name 24 and location of the court. All persons who may have claims 25 against the assets of the title insurance company, as 26 distinguished from the assets of insureds and escrow depositors 27 28 held by the title insurance company, and the receiver to whom those persons have presented their claims may present the 29 claims to the clerk of the court, and the allowance or 30 31 disallowance of the claims by the court in connection with the proceedings shall be deemed an adjudication in a court of 32 competent jurisdiction. Within a reasonable time after 33 completion of publication, the receiver shall file with the 34 court a correct list of all creditors of the title insurance 35 company as shown by its books, who have not presented their 36

claims and the amount of their respective claims after allowing
adjusted credit, deductions, and set-offs as shown by the books
of the title insurance company. The claims so filed shall be
deemed proven unless objections are filed thereto by a party or
parties interested therein within the time fixed by the court.
(j) The receiver for a title insurance company has the
power and authority and is charged with the duties and
responsibilities as follows:
(1) To take possession of and, for the purpose of the
receivership, title to the books, records, and assets of
every description of the title insurance company.
(2) To proceed to collect all debts, dues, and claims
belonging to the title insurance company.
(3) To sell and compound all bad and doubtful debts on
such terms as the court shall direct.
(4) To sell the real and personal property of the title
insurance company, as distinguished from the real and
personal property of the insureds or escrow depositors, on
such terms as the court shall direct.
(5) To file with the Secretary a copy of each report
that he or she makes to the court, together with such other
reports and records as the Secretary may require.
(6) To sue and defend in his or her own name and with
respect to the affairs, assets, claims, debts, and choses
in action of the title insurance company.
(7) To surrender to the insureds and escrow depositors
of the title insurance company, when requested in writing
directed to the receiver by them, the escrowed funds (on a
pro rata basis), and escrowed documents in the receiver's
possession upon satisfactory proof of ownership and
determination by the receiver of available escrow funds.
(8) To redeem or take down collateral hypothecated by
the title insurance company to secure its notes and other
evidence of indebtedness whenever the court deems it to be
in the best interest of the creditors of the title
insurance company and directs the receiver so to do.

1 (k) Whenever the receiver finds it necessary in his or her 2 opinion to use and employ money of the title insurance company in order to protect fully and benefit the title insurance 3 company by the purchase or redemption of property, real or 4 5 personal, in which the title insurance company may have any rights by reason of any bond, mortgage, assignment, or other 6 claim thereto, the receiver may certify the facts together with 7 the receiver's opinions as to the value of the property 8 9 involved and the value of the equity the title insurance company may have in the property to the court, together with a 10 11 request for the right and authority to use and employ so much 12 of the money of the title insurance company as may be necessary 13 to purchase the property, or to redeem the property from a sale if there was a sale, and if the request is granted, the 14 receiver may use so much of the money of the title insurance 15 16 company as the court may have authorized to purchase the 17 property at the sale. The receiver shall deposit daily all moneys collected by 18 him or her in any State or national bank approved by the court. 19 20 The deposits shall be made in the name of the Secretary, in trust for the receiver, and be subject to withdrawal upon the 21 receiver's order or upon the order of those persons the 22 Secretary may designate. The moneys may be deposited without 23 interest, unless otherwise agreed. The receiver shall do the 24

things and take the steps from time to time under the direction 25 and approval of the court that may reasonably appear to be 26 27 necessary to conserve the title insurance company's assets and secure the best interests of the creditors, insureds, and 28 escrow depositors of the title insurance company. The receiver 29 shall record any judgment of dissolution entered in a 30 31 dissolution proceeding and thereupon turn over to the Secretary a certified copy of the judgment. 32

33 <u>The receiver may cause all assets of the insureds and</u> 34 <u>escrow depositors of the title insurance company to be</u> 35 <u>registered in the name of the receiver or in the name of the</u> 36 <u>receiver's nominee.</u>

1 For its services in administering the escrows held by the 2 title insurance company during the period of winding up the affairs of the title insurance company, the receiver is 3 entitled to be reimbursed for all costs and expenses incurred 4 5 by the receiver and shall also be entitled to receive out of the assets of the individual escrows being administered by the 6 receiver during the period of winding up the affairs of the 7 title insurance company and prior to the appointment of a 8 9 successor escrowee the usual and customary fees charged by an escrowee for escrows or reasonable fees approved by the court. 10

11 <u>The receiver, during its administration of the escrows of</u> 12 <u>the title insurance company during the winding up of the</u> 13 <u>affairs of the title insurance company, shall have all of the</u> 14 <u>powers that are vested in trustees under the terms and</u> 15 <u>provisions of the Trusts and Trustees Act.</u>

16 <u>Upon the appointment of a successor escrowee, the receiver</u> 17 <u>shall deliver to the successor escrowee all of the assets</u> 18 <u>belonging to each individual escrow to which the successor</u> 19 <u>escrowee succeeds, and the receiver shall thereupon be relieved</u> 20 <u>of any further duties or obligations with respect thereto.</u>

1 <u>(3) Secured claims, including claims for taxes and</u> 2 <u>debts due the federal or any state or local government,</u> 3 <u>that are secured by liens perfected prior to the date of</u> 4 <u>filing of the complaint for dissolution, shall be paid from</u> 5 <u>the assets of the title insurance company.</u>

(4) Claims by policyholders, beneficiaries, insureds, and escrow depositors of the title insurance company shall be paid from the assets of the insureds and escrow depositors. If there are insufficient assets of the insureds and escrow depositors, claims shall be paid from the assets of the title insurance company.

(5) Any other claims due the federal government shall be paid from the assets of the title insurance company.

14 (6) Claims for wages or salaries, excluding vacation, 15 severance, and sick leave pay earned by employees for 16 services rendered within 90 days prior to the date of 17 filing of the complaint for dissolution, shall be paid from 18 the assets of the title insurance company.

19 <u>(7) All other claims of general creditors not falling</u> 20 <u>within any priority under this subsection (1) including</u> 21 <u>claims for taxes and debts due any state or local</u> 22 <u>government which are not secured claims and claims for</u> 23 <u>attorney's fees incurred by the title insurance company in</u> 24 <u>contesting the dissolution shall be paid from the assets of</u> 25 the title insurance company.
