## SYNOPSIS AS INTRODUCED:

625 ILCS 5/15-111

from Ch. 95 1/2, par. 15-111

Amends the Illinois Vehicle Code. Provides that certain specially equipped vehicles used solely for recycling (as well as those used solely for garbage or refuse) hauls or operations are subject to special weight limits when not operating on interstate highways.

### Be it enacted by the People of the State of Illinois, 2 represented in the General Assembly: 3

Section 5. The Illinois Vehicle Code is amended by changing 4 5 Section 15-111 as follows:

(625 ILCS 5/15-111) (from Ch. 95 1/2, par. 15-111) 6

Sec. 15-111. Wheel and axle loads and gross weights.

7

8 (a) On non-designated highways, no vehicle or combination of vehicles equipped with pneumatic tires may be operated, 9 unladen or with load, when the total weight transmitted to the 10 road surface exceeds 18,000 pounds on a single axle or 32,000 11 pounds on a tandem axle with no axle within the tandem 12 exceeding 18,000 pounds except: 13

14 (1) when a different limit is established and posted in 15 accordance with Section 15-316 of this Code;

(2) vehicles for which the Department 16 of Transportation and local authorities issue overweight 17 18 permits under authority of Section 15-301 of this Code;

19 (3) tow trucks subject to the conditions provided in subsection (d) may not exceed 24,000 pounds on a single 20 rear axle or 44,000 pounds on a tandem rear axle; 21

(4) any single axle of a 2-axle truck weighing 36,000 22 pounds or less and not a part of a combination of vehicles, 23 shall not exceed 20,000 pounds; 24

25 (5) any single axle of a 2-axle truck equipped with a personnel lift or digger derrick, weighing 36,000 pounds or 26 less, owned and operated by a public utility, shall not 27 exceed 20,000 pounds; 28

29 (6) any single axle of a 2-axle truck specially 30 equipped with a front loading compactor used exclusively for garbage, refuse, or recycling may not exceed 20,000 31 pounds per axle, provided that the gross weight of the 32

vehicle does not exceed 40,000 pounds;

(7) a truck, not in combination and specially equipped with a selfcompactor or an industrial roll-off hoist and roll-off container, used exclusively for garbage or refuse operations may, when laden, transmit upon the road surface the following maximum weights: 22,000 pounds on a single axle; 40,000 pounds on a tandem axle;

(8) a truck, not in combination and used exclusively 9 for the collection of rendering materials, may, when laden, 10 transmit upon the road surface the following maximum 11 weights: 22,000 pounds on a single axle; 40,000 pounds on a 12 tandem axle;

(9) tandem axles on a 3-axle truck registered as a 13 Special Hauling Vehicle, manufactured prior to or in the 14 model year of 2014 and first registered in Illinois prior 15 16 to January 1, 2015, with a distance greater than 72 inches 17 but not more than 96 inches between any series of 2 axles, is allowed a combined weight on the series not to exceed 18 36,000 pounds and neither axle of the series may exceed 19 20 18,000 pounds. Any vehicle of this type manufactured after the model year of 2014 or first registered in Illinois 21 after December 31, 2014 may not exceed a combined weight of 22 32,000 pounds through the series of 2 axles and neither 23 axle of the series may exceed 18,000 pounds; 24

25 (10) tandem axles on a 4-axle truck mixer, whose fourth 26 axle is a road surface engaging mixer trailing axle, 27 registered as a Special Hauling Vehicle, used exclusively 28 the mixing and transportation of concrete for and manufactured prior to or in the model year of 2014 and 29 30 first registered in Illinois prior to January 1, 2015, with 31 a distance greater than 72 inches but not more than 96 32 inches between any series of 2 axles, is allowed a combined weight on the series not to exceed 36,000 pounds and 33 neither axle of the series may exceed 18,000 pounds. Any 34 vehicle of this type manufactured after the model year of 35 2014 or first registered in Illinois after December 31, 36

2014 may not exceed a combined weight of 32,000 pounds
 through the series of 2 axles and neither axle of the
 series may exceed 18,000 pounds;

(11) 4-axle vehicles or a 5 or more axle combination of 4 5 vehicles: The weight transmitted upon the road surface 6 through any series of 3 axles whose centers are more than 96 inches apart, measured between extreme axles in the 7 series, may not exceed those allowed in the table contained 8 9 in subsection (f) of this Section. No axle or tandem axle of the series may exceed the maximum weight permitted under 10 11 this Section for a single or tandem axle.

No vehicle or combination of vehicles equipped with other than pneumatic tires may be operated, unladen or with load, upon the highways of this State when the gross weight on the road surface through any wheel exceeds 800 pounds per inch width of tire tread or when the gross weight on the road surface through any axle exceeds 16,000 pounds.

(b) On non-designated highways, the gross weight of vehicles and combination of vehicles including the weight of the vehicle or combination and its maximum load shall be subject to the foregoing limitations and further shall not exceed the following gross weights dependent upon the number of axles and distance between extreme axles of the vehicle or combination measured longitudinally to the nearest foot.

(d) Weight limitations shall not apply to vehicles
(including loads) operated by a public utility when
transporting equipment required for emergency repair of public
utility facilities or properties or water wells.

1 exceeds the weight restriction imposed by this Code, may be 2 operated on a public highway in this State provided that neither the disabled vehicle nor any vehicle being towed nor 3 the tow truck itself shall exceed the weight limitations 4 5 permitted under this Chapter. During the towing operation, 6 neither the tow truck nor the vehicle combination shall exceed 24,000 pounds on a single rear axle and 44,000 pounds on a 7 tandem rear axle, provided the towing vehicle: 8

9 (1) is specifically designed as a tow truck having a 10 gross vehicle weight rating of at least 18,000 pounds and 11 is equipped with air brakes, provided that air brakes are 12 required only if the towing vehicle is towing a vehicle, 13 semitrailer, or tractor-trailer combination that is 14 equipped with air brakes;

(2) is equipped with flashing, rotating, or
oscillating amber lights, visible for at least 500 feet in
all directions;

(3) is capable of utilizing the lighting and braking
systems of the disabled vehicle or combination of vehicles;
and

(4) does not engage in a tow exceeding 20 miles from 21 the initial point of wreck or disablement. Any additional 22 23 movement of the vehicles may occur only upon issuance of authorization for that movement under the provisions of 24 Sections 15-301 through 15-319 of this Code. The towing 25 vehicle, however, may tow any disabled vehicle from the 26 27 initial point of wreck or disablement to a point where 28 repairs are actually to occur. This movement shall be valid 29 only on State routes. The tower must abide by posted bridge 30 weight limits.

Gross weight limits shall not apply to the combination of the tow truck and vehicles being towed. The tow truck license plate must cover the operating empty weight of the tow truck only. The weight of each vehicle being towed shall be covered by a valid license plate issued to the owner or operator of the vehicle being towed and displayed on that vehicle. If no valid

1 plate issued to the owner or operator of that vehicle is 2 displayed on that vehicle, or the plate displayed on that 3 vehicle does not cover the weight of the vehicle, the weight of 4 the vehicle shall be covered by the third tow truck plate 5 issued to the owner or operator of the tow truck and 6 temporarily affixed to the vehicle being towed.

7 Department may by rule or regulation prescribe The 8 additional requirements. However, nothing in this Code shall 9 prohibit a tow truck under instructions of a police officer from legally clearing a disabled vehicle, that may be in 10 11 violation of weight limitations of this Chapter, from the 12 roadway to the berm or shoulder of the highway. If in the 13 opinion of the police officer that location is unsafe, the officer is authorized to have the disabled vehicle towed to the 14 15 nearest place of safety.

For the purpose of this subsection, gross vehicle weight rating, or GVWR, shall mean the value specified by the manufacturer as the loaded weight of the tow truck.

(e) No vehicle or combination of vehicles equipped with pneumatic tires shall be operated, unladen or with load, upon the highways of this State in violation of the provisions of any permit issued under the provisions of Sections 15-301 through 15-319 of this Chapter.

24 (f) On designated Class I, II, or III highways and the National System of Interstate and Defense Highways, no vehicle 25 26 or combination of vehicles with pneumatic tires may be 27 operated, unladen or with load, when the total weight on the road surface exceeds the following: 20,000 pounds on a single 28 29 axle; 34,000 pounds on a tandem axle with no axle within the 30 tandem exceeding 20,000 pounds; 80,000 pounds gross weight for vehicle combinations of 5 or more axles; or a total weight on a 31 32 group of 2 or more consecutive axles in excess of that weight produced by the application of the following formula: W = 50033 times the sum of (LN divided by N-1) + 12N + 36, where "W" 34 35 equals overall total weight on any group of 2 or more consecutive axles to the nearest 500 pounds, "L" equals the 36

Vehicles not in a combination having more than 4 axles may
 not exceed the weight in the table in this subsection (f) for 4
 axles measured between the extreme axles of the vehicle.

Vehicles in a combination having more than 6 axles may not exceed the weight in the table in this subsection (f) for 6 axles measured between the extreme axles of the combination.

Local authorities, with respect to streets and highways 7 under their jurisdiction, without additional fees, may also by 8 9 ordinance or resolution allow the weight limitations of this 10 subsection, provided the maximum gross weight on any one axle 11 shall not exceed 20,000 pounds and the maximum total weight on 12 any tandem axle shall not exceed 34,000 pounds, on designated highways when appropriate regulatory signs giving notice are 13 erected upon the street or highway or portion of any street or 14 highway affected by the ordinance or resolution. 15

The following are exceptions to the above formula:

17 (1) Two consecutive sets of tandem axles may carry a
18 total weight of 34,000 pounds each if the overall distance
19 between the first and last axles of the consecutive sets of
20 tandem axles is 36 feet or more.

(2) Vehicles for which a different limit is established
 and posted in accordance with Section 15-316 of this Code.

(3) Vehicles for which the Department of
Transportation and local authorities issue overweight
permits under authority of Section 15-301 of this Code.
These vehicles are not subject to the bridge formula.

(4) Tow trucks subject to the conditions provided in
subsection (d) may not exceed 24,000 pounds on a single
rear axle or 44,000 pounds on a tandem rear axle.

30 (5) A tandem axle on a 3-axle truck registered as a 31 Special Hauling Vehicle, manufactured prior to or in the 32 model year of 2014, and registered in Illinois prior to 33 January 1, 2015, with a distance between 2 axles in a 34 series greater than 72 inches but not more than 96 inches 35 may not exceed a total weight of 36,000 pounds and neither 36 axle of the series may exceed 18,000 pounds.

1 (6) A truck not in combination, equipped with a self 2 compactor or an industrial roll-off hoist and roll-off 3 container, used exclusively for garbage, or refuse, or recycling operations, may, when laden, transmit upon the 4 5 road surface, except when on part of the National System of 6 Interstate and Defense Highways, the following maximum weights: 22,000 pounds on a single axle; 40,000 pounds on a 7 tandem axle; 36,000 pounds gross weight on a 2-axle 8 9 vehicle; 54,000 pounds gross weight on a 3-axle vehicle. 10 This vehicle is not subject to the bridge formula.

11 (7) Combinations of vehicles, registered as Special 12 Hauling Vehicles that include a semitrailer manufactured prior to or in the model year of 2014, and registered in 13 Illinois prior to January 1, 2015, having 5 axles with a 14 distance of 42 feet or less between extreme axles, may not 15 16 exceed the following maximum weights: 18,000 pounds on a 17 single axle; 32,000 pounds on a tandem axle; and 72,000 pounds gross weight. This combination of vehicles is not 18 subject to the bridge formula. For all those combinations 19 of vehicles that include a semitrailer manufactured after 20 the effective date of this amendatory Act of the 92nd 21 General Assembly, the overall distance between the first 22 and last axles of the 2 sets of tandems must be 18 feet 6 23 inches or more. Any combination of vehicles that has had 24 25 its cargo container replaced in its entirety after December 31, 2014 may not exceed the weights allowed by the bridge 26 27 formula.

No vehicle or combination of vehicles equipped with other than pneumatic tires may be operated, unladen or with load, upon the highways of this State when the gross weight on the road surface through any wheel exceeds 800 pounds per inch width of tire tread or when the gross weight on the road surface through any axle exceeds 16,000 pounds.

34 (f-1) A vehicle and load not exceeding 73,280 pounds is 35 allowed access as follows:

(A) The vehicle and load does not exceed 8 feet 6
 inches in width and 65 feet overall length.

(B) There is no sign prohibiting that access.

6 (C) The route is not being used as a thoroughfare 7 between State designated highways.

8 (2) From any State designated highway onto any county 9 or township highway for a distance of 5 highway miles, or 10 any municipal highway for a distance of one highway mile 11 for the purpose of food, fuel, repairs, and rest, provided:

(A) The vehicle and load does not exceed 8 feet 6
 inches in width and 65 feet overall length.

(B) There is no sign prohibiting that access.

15 (C) The route is not being used as a thoroughfare16 between State designated highways.

17 (f-2) A vehicle and load greater than 73,280 pounds in 18 weight but not exceeding 80,000 pounds is allowed access as 19 follows:

(1) From a Class I highway onto any street or highway
for a distance of one highway mile for the purpose of
loading, unloading, food, fuel, repairs, and rest,
provided there is no sign prohibiting that access.

(2) From a Class I, II, or III highway onto any State
highway or any local designated highway for a distance of 5
highway miles for the purpose of loading, unloading, food,
fuel, repairs, and rest.

28 Section 5-35 of the Illinois Administrative Procedure Act 29 relating to procedures for rulemaking shall not apply to the 30 designation of highways under this subsection.

(g) No person shall operate a vehicle or combination of vehicles over a bridge or other elevated structure constituting part of a highway with a gross weight that is greater than the maximum weight permitted by the Department, when the structure is sign posted as provided in this Section.

(h) The Department upon request from any local authority

1 shall, or upon its own initiative may, conduct an investigation 2 of any bridge or other elevated structure constituting a part 3 of a highway, and if it finds that the structure cannot with 4 safety to itself withstand the weight of vehicles otherwise 5 permissible under this Code the Department shall determine and declare the maximum weight of vehicles that the structures can 6 withstand, and shall cause or permit suitable signs stating 7 8 maximum weight to be erected and maintained before each end of 9 the structure. No person shall operate a vehicle or combination 10 of vehicles over any structure with a gross weight that is 11 greater than the posted maximum weight.

(i) Upon the trial of any person charged with a violation of subsections (g) or (h) of this Section, proof of the determination of the maximum allowable weight by the Department and the existence of the signs, constitutes conclusive evidence of the maximum weight that can be maintained with safety to the bridge or structure.
