- Section 5. The Mental Health and Developmental Disabilities Code is amended by changing Section 3-801 and adding Section 3-801.5 as follows:

- of the respondent's illness and treatment demonstrating that

- (1) The court and the parties have been presented with a written report pursuant to Section 3-810 of this Code containing a recommendation for alternative treatment or care and custody and setting forth in detail the conditions for such an order, and the court is satisfied that the proposal for alternative treatment or care and custody is in the best interest of the respondent and of the public.
- (2) The court advises the respondent of the conditions of the proposed order in open court and is satisfied that the respondent understands and agrees to the conditions of the proposed order for alternative treatment or care and custody.
- (3) The proposed custodian is advised of the recommendation for care and custody and agrees to abide by the terms of the proposed order.
- (4) No such order may require the respondent to be hospitalized except as provided in subsection (b) of this Section.
- (5) No order may include as one of its conditions the administration of psychotropic medication, unless the court determines, based on the documented history of the respondent's treatment and illness, that the respondent is unlikely to continue to receive needed psychotropic medication in the absence of such an order.
- (b) An agreed order of care and custody entered pursuant to this Section may grant the custodian the authority to admit a respondent to a hospital if the respondent fails to comply with the conditions of the agreed order. If necessary in order to obtain the hospitalization of the respondent, the custodian may apply to the court for an order authorizing an officer of the peace to take the respondent into custody and transport the respondent to the hospital specified in the agreed order.
