### SYNOPSIS AS INTRODUCED:

Makes appropriations and reappropriations to the Board of Trustees of Eastern Illinois University for various purposes. Effective July 1, 2005.

A BILL FOR

1 AN ACT making appropriations and reappropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much  
5 thereof as may be necessary, for the purposes hereinafter  
6 named, are appropriated from the General Revenue Fund to the  
7 Board of Trustees of Eastern Illinois University to meet the  
8 ordinary and contingent expenses of the University, including  
9 payment or reimbursement to the University for personal  
10 services and related costs incurred during the fiscal year  
11 ending June 30, 2006 and for salaries, commodities,  
12 contractual services, equipment, and telecommunications  
13 accrued during fiscal year 2005 but remaining unpaid on June  
14 30, 2005:

15	Personnel Services .....	\$45,357,200
16	Contractual Services .....	1,700,000
17	Commodities .....	500,000
18	Equipment .....	500,000
19	Telecommunications .....	<u>300,000</u>
20	Total	\$48,357,200

22 Section 10. The sum of \$393,294, or so much thereof as  
23 may be necessary and remains unexpended at the close of  
24 business on June 30, 2005, from a reappropriation heretofore  
25 made for such purpose in Article 106, Section 20 of Public  
26 Act 93-842, is reappropriated from the Capital Development  
27 Fund to the Board of Trustees of Eastern Illinois University  
28 to purchase equipment for the renovation and expansion of  
29 Booth Library. No contract shall be entered into or  
30 obligation incurred for any expenditure from the  
31 appropriation made in this Section until after the purposes  
32 and amounts have been approved in writing by the Governor.

2 Section 15. The sum of \$1,500,000, or so much thereof as  
3 may be necessary and remains unexpended at the close of  
4 business on June 30, 2005, from a reappropriation heretofore  
5 made for such purpose in Article 106, Section 15 of Public  
6 Act 93-842, is reappropriated from the Capital Development  
7 Fund to the Board of Trustees of Eastern Illinois University  
8 to purchase equipment for the renovation and expansion of the  
9 Fine Arts Center. No contract shall be entered into or  
10 obligation incurred for any expenditure from the  
11 appropriation made in this Section until after the purposes  
12 and amounts have been approved in writing by the Governor.

14 Section 17. The sum of \$1,500,000, or so much thereof as  
15 may be necessary, is appropriated from the Capital  
16 Development Fund to the Board of Trustees of Eastern Illinois  
17 University to purchase equipment for the renovation and  
18 expansion of the Fine Arts Center. No contract shall be  
19 entered into or obligation incurred for any expenditure from  
20 the appropriation made in this Section until after the  
21 purposes and amounts have been approved in writing by the  
22 Governor.

24 Section 20. The sum of \$2,000, or so much thereof as may  
25 be necessary, is appropriated from the State College and  
26 University Trust Fund to the Board of Trustees of Eastern  
27 Illinois University for scholarship grant awards, in  
28 accordance with Public Act 91-83. No contract shall be  
29 entered into or obligation incurred for any expenditure from  
30 the appropriation made in this Section until after the  
31 purposes and amounts have been approved in writing by the  
32 Governor.

33 Section 99. Effective date. This Act takes effect July 1,
