Makes appropriations and reappropriations to the Board of Trustees of Eastern Illinois University for various purposes. Effective July 1, 2005.

AN ACT making appropriations and reappropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

The following named amounts, or so much 4 Section 5. thereof as may be necessary, for the purposes hereinafter 5 named, are appropriated from the General Revenue Fund to the 6 7 Board of Trustees of Eastern Illinois University to meet the ordinary and contingent expenses of the University, including 8 9 payment or reimbursement to the University for personal services and related costs incurred during the fiscal year 10 June 30, 2006 and for 11 ending salaries, commodities, contractual services, equipment, and telecommunications 12 accrued during fiscal year 2005 but remaining unpaid on June 13 30, 2005: 14

Section 10. The sum of \$393,294, or so much thereof as 22 23 may be necessary and remains unexpended at the close of 24 business on June 30, 2005, from a reappropriation heretofore made for such purpose in Article 106, Section 20 of Public 25 Act 93-842, is reappropriated from the Capital Development 26 Fund to the Board of Trustees of Eastern Illinois University 27 to purchase equipment for the renovation and expansion of 28 29 Booth Library. No contract shall be entered into or 30 obligation incurred for any expenditure from the appropriation made in this Section until after the purposes 31 32 and amounts have been approved in writing by the Governor.

Section 15. The sum of \$5,430,384, or so much thereof as 2 may be necessary and remains unexpended at the close of 3 business on June 30, 2005, from a reappropriation heretofore 4 made for such purpose in Article 106, Section 15 of Public 5 6 Act 93-842, is reappropriated from the Capital Development Fund to the Board of Trustees of Eastern Illinois University 7 to purchase equipment for the renovation and expansion of the 8 Fine Arts Center. No contract shall be entered into or 9 obligation incurred for any expenditure from 10 the appropriation made in this Section until after the purposes 11 and amounts have been approved in writing by the Governor. 12

Section 17. The sum of \$1,500,000, or so much thereof as 14 necessary, is appropriated from the 15 may be Capital Development Fund to the Board of Trustees of Eastern Illinois 16 University to purchase equipment for the renovation and 17 expansion of the Fine Arts Center. No contract shall be 18 entered into or obligation incurred for any expenditure from 19 20 the appropriation made in this Section until after the purposes and amounts have been approved in writing by the 21 22 Governor.

Section 20. The sum of \$2,000, or so much thereof as may 24 25 be necessary, is appropriated from the State College and 26 University Trust Fund to the Board of Trustees of Eastern Illinois University for scholarship grant awards, 27 in accordance with Public Act 91-83. No contract shall be 28 entered into or obligation incurred for any expenditure from 29 the appropriation made in this Section until after the 30 31 purposes and amounts have been approved in writing by the 32 Governor.
