A BILL FOR

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much  
5 thereof as may be necessary, respectively, are appropriated  
6 to the Court of Claims for its ordinary and contingent  
7 expenses:

26 Section 10. The amount of \$300,000, or so much of that  
27 amount as may be necessary, is appropriated from the Court of  
28 Claims Administration and Grant Fund to the Court of Claims  
29 for administrative expenses under the Crime Victims  
30 Compensation Act.

1 Section 15. The amount of \$500,000, or so much of that  
 2 amount as may be necessary, is appropriated from the General  
 3 Revenue Fund to the Court of Claims for payment of awards  
 4 solely as a result of the lapsing of an appropriation  
 5 originally made from any funds held by the State Treasurer.

6 Section 20. The following named amounts, or so much of  
 7 that amount as may be necessary, are appropriated to the  
 8 Court of Claims for payment of claims as follows:

9 For claims under the Crime Victims

10 Compensation Act:

11 Payable from General Revenue

12 Fund .....24,000,000

13 For claims other than Crime Victims:

14 Payable from the General

15 Revenue Fund .....15,000,000

16 Payable from the

17 Road Fund .....1,000,000
