**SYNOPSIS AS INTRODUCED:**

Makes appropriations to each public university of the State for a one-time pay increase for non-administrative university staff and faculty. Effective July 1, 2006.

**A BILL FOR**

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. The amount of \$0, or so much thereof as may  
5 be necessary is appropriated from the General Revenue Fund to  
6 the Board of Trustees of Chicago State University for a one-  
7 time pay increase for non-administrative university staff and  
8 faculty.

9 Section 10. The amount of \$0, or so much thereof as may  
10 be necessary is appropriated from the General Revenue Fund to  
11 the Board of Trustees of Eastern Illinois University for a  
12 one-time pay increase for non-administrative university staff  
13 and faculty.

14 Section 15. The amount of \$0, or so much thereof as may  
15 be necessary is appropriated from the General Revenue Fund to  
16 the Board of Trustees of Governors State University for a  
17 one-time pay increase for non-administrative university staff  
18 and faculty.

19 Section 20. The amount of \$0, or so much thereof as may  
20 be necessary is appropriated from the General Revenue Fund to  
21 the Board of Trustees of Illinois State University for a one-  
22 time pay increase for non-administrative university staff and  
23 faculty.

24 Section 25. The amount of \$0, or so much thereof as may  
25 be necessary is appropriated from the General Revenue Fund to  
26 the Board of Trustees of Northeastern Illinois University for  
27 a one-time pay increase for non-administrative university  
28 staff and faculty.

1           Section 30. The amount of \$0, or so much thereof as may  
2 be necessary is appropriated from the General Revenue Fund to  
3 the Board of Trustees of Northern Illinois University for a  
4 one-time pay increase for non-administrative university staff  
5 and faculty.

6           Section 35. The amount of \$0, or so much thereof as may  
7 be necessary is appropriated from the General Revenue Fund to  
8 the Board of Trustees of Southern Illinois University for a  
9 one-time pay increase for non-administrative university staff  
10 and faculty.

11           Section 40. The amount of \$0, or so much thereof as may  
12 be necessary is appropriated from the General Revenue Fund to  
13 the Board of Trustees of the University of Illinois for a  
14 one-time pay increase for non-administrative university staff  
15 and faculty.

16           Section 45. The amount of \$0, or so much thereof as may  
17 be necessary is appropriated from the General Revenue Fund to  
18 the Board of Trustees of Western Illinois University for a  
19 one-time pay increase for non-administrative university staff  
20 and faculty.

21           Section 99. Effective date. This Act takes effect July 1,  
22 2006.
