

94TH GENERAL ASSEMBLY State of Illinois 2005 and 2006 HB5534

Introduced 1/27/2006, by Rep. Robert W. Pritchard

SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-815.1

Amends the Illinois Vehicle Code. In a Section concerning the commercial distribution fee, provides that, beginning January 1, 2007 and through December 31, 2012, for each registration year, the owner of a vehicle for which biodiesel has been purchased during the previous registration year is entitled to a reduction of the fee for that vehicle. Sets forth the amount of the reduction based upon the amount of biodiesel purchased. Makes technical changes. Effective immediately.

FISCAL NOTE ACT MAY APPLY

1 AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Vehicle Code is amended by changing Section 3-815.1 as follows:

- Sec. 3-815.1. Commercial distribution fee. Beginning July 1, 2003, in addition to any tax or fee imposed under this Code:
- (a) Owners of vehicles Vehicles of the second division 9 with a gross vehicle weight that exceeds 8,000 pounds and 10 that incur any tax or fee under subsection (a) of Section 11 3-815 of this Code or subsection (a) of Section 3-818 of 12 this Code, as applicable, shall pay to the Secretary of 13 14 State a commercial distribution fee, for each registration 15 year, for the use of the public highways, State infrastructure, and State services, in an amount equal to: 16 (i) for a registration year beginning on or after July 1, 17 2003 and before July 1, 2005, 36% of the taxes and fees 18 19 incurred under subsection (a) of Section 3-815 of this Code, or subsection (a) of Section 3-818 of this Code, as 20 applicable, rounded up to the nearest whole dollar; (ii) 21 for a registration year beginning on or after July 1, 2005 22 and before July 1, 2006, 21.5% of the taxes and fees 23 incurred under subsection (a) of Section 3-815 of this 24 25 Code, or subsection (a) of Section 3-818 of this Code, as 26 applicable, rounded up to the nearest whole dollar; and 27 (iii) for a registration year beginning on or after July 1, 2006, 14.35% of the taxes and fees incurred under 28 subsection (a) of Section 3-815 of this Code, or subsection 29 30 (a) of Section 3-818 of this Code, as applicable, rounded up to the nearest whole dollar. 31
 - (b) Until June 30, 2004, owners of vehicles of the

second division with a gross vehicle weight of 8,000 pounds or less and that incur any tax or fee under subsection (a) of Section 3-815 of this Code or subsection (a) of Section 3-818 of this Code, as applicable, and have claimed the rolling stock exemption under the Retailers' Occupation Tax Act, Use Tax Act, Service Occupation Tax Act, or Service Use Tax Act shall pay to the Illinois Department of the Secretary of State Revenue (or under an intergovernmental agreement) a commercial distribution fee, for each registration year, for the use of the public highways, State infrastructure, and State services, in an amount equal to 36% of the taxes and fees incurred under subsection (a) of Section 3-815 of this Code or subsection (a) of Section 3-818 of this Code, as applicable, rounded up to the nearest whole dollar.

The fees paid under this Section shall be deposited by the Secretary of State into the General Revenue Fund.

Beginning January 1, 2007 and through December 31, 2012, for each registration year, the owner of a vehicle for which biodiesel has been purchased during the previous registration year is entitled to a reduction of the fees imposed under this Section for that vehicle. The amount of the reduction is:

- (1) 50% of the fees imposed if the owner purchased \$10,000 or more worth of biodiesel for the vehicle during the previous registration year;
- (2) 25% of the fees imposed if the owner purchased \$5,000 or more but less than \$10,000 worth of biodiesel for the vehicle during the previous registration year; or
- (3) 15% of the fees imposed if the owner purchased \$2,500 or more but less than \$5,000 worth of biodiesel for the vehicle during the previous registration year.

For the purpose of this paragraph, "biodiesel" has the meaning set forth under Section 10 of the Illinois Renewable Fuels

Development Program Act. The Secretary of State must adopt rules to administer this paragraph, including, without limitation, rules concerning application procedures and the
