# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

#### ARTICLE 1

Section 5. 28 Section 10. The following named sums, or so much thereof 29 as may be necessary, respectively, for the objects and 30 purposes hereinafter named, are appropriated to the Illinois

16 Section 15. The sum of \$992,000, or so much thereof as 17 may be necessary, is appropriated from the General Revenue 18 Fund to the Illinois Arts Council for the purpose of funding 19 administrative and grant expenses associated with humanities 20 programs and related activities.

21 Section 20. The amount of \$377,100, or so much thereof 22 as may be necessary, is appropriated from the General Revenue 23 Fund to the Illinois Arts Council for grants to certain 24 public radio and television stations for operating costs.

Section 25. The amount of \$4,860,600, or so much thereof 25 as may be necessary is appropriated from the General Revenue 26 Fund to the Illinois Arts Council for grants to certain 27 28 public radio and television stations and related administrative expenses, pursuant to the Public Radio and 29 Television Grant Act. 30
