1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named sums, or so much thereof
6 as may be necessary, respectively, for the objects and
7 purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Illinois Arts
9 Council:

28 Section 10. The following named sums, or so much thereof
29 as may be necessary, respectively, for the objects and
30 purposes hereinafter named, are appropriated to the Illinois

12 Payable from Illinois Arts Council

16 Section 15. The sum of \$992,000, or so much thereof as
17 may be necessary, is appropriated from the General Revenue
18 Fund to the Illinois Arts Council for the purpose of funding
19 administrative and grant expenses associated with humanities
20 programs and related activities.

21 Section 20. The amount of \$377,100, or so much thereof
22 as may be necessary, is appropriated from the General Revenue
23 Fund to the Illinois Arts Council for grants to certain
24 public radio and television stations for operating costs.

25 Section 25. The amount of \$4,860,600, or so much thereof
26 as may be necessary is appropriated from the General Revenue
27 Fund to the Illinois Arts Council for grants to certain
28 public radio and television stations and related
29 administrative expenses, pursuant to the Public Radio and
30 Television Grant Act.

1 Section 99. Effective date. This Act takes effect July 1,
2 2006.
