Section 5. In addition to the amounts heretofore 14 appropriated, the following named amount, or so much thereof 15 as may be necessary, is appropriated from the Illinois 16 Workers' Compensation Commission Operations Fund to the 17 Illinois Workers' Compensation Commission for the project 18 hereinafter enumerated:

22 Section 15. The amount of \$115,000, or so much thereof 23 as may be necessary, is appropriated from the Illinois 24 Workers' Compensation Commission Operations Fund to the 25 Illinois Workers' Compensation Commission for printing and 26 distribution of Workers' Compensation handbooks containing 27 information as to the rights and obligations of employers.

28 Section 20. The amount of \$244,200, or so much thereof 29 as may be necessary, is appropriated from the Illinois 30 Workers' Compensation Commission Operations Fund to the 31 Illinois Workers' Compensation Commission for the HB5743 -3- OMB094 00225 KRO 30225 b

1 implementation and operation of an accident reporting system.

2 Section 25. The sum of \$118,000, or so much thereof as 3 may be necessary, is appropriated from the Illinois Workers' 4 Compensation Commission Operations Fund to the Illinois 5 Workers' Compensation Commission for all costs associated 6 with the establishment and operation of a satellite office in 7 the Metro East area.

The amount of \$800,000, or so much thereof 8 Section 30. 9 as may be necessary, is appropriated from the Illinois Workers' Compensation Commission Operations Fund to Illinois 10 Workers' Compensation Commission for costs associated with 11 the establishment, administration and operations of 12 the Insurance Compliance Division of the workers' compensation 13 14 anti-fraud program administered by Illinois Workers' Compensation Commission. 15

16 Section 35. The amount of \$940,000, or so much thereof 17 as may be necessary, is appropriated from the Illinois 18 Workers' Compensation Commission Operations Fund to Illinois 19 Workers' Compensation Commission for all costs associated 20 with the establishment, administration and operation of a 21 third Commission panel

22 Section 40. The amount of \$250,000, or so much thereof 23 as may be necessary, is appropriated from the Illinois 24 Workers' Compensation Commission Operations Fund to Illinois 25 Workers' Compensation Commission for costs associated with 26 the establishment of the Medical Fee Schedule and other 27 provisions of the Workers Compensation Act.

28 Section 99. Effective date. This Act takes effect July 1,29 2006.
