A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named sums, or so much thereof  
6 as may be necessary, respectively, for the objects and  
7 purposes hereinafter named, are appropriated from the General  
8 Revenue Fund to meet the ordinary and contingent expenses of

32 Section 30. The sum of \$9,500,000, or so much thereof as  
33 may be necessary, is appropriated from the Department of



1 Corrections Reimbursement and Education Fund to meet the  
 2 ordinary and contingent expenses of the Department of  
 3 Juvenile Justice described below and having the estimated  
 4 cost as follows:

5	For payment of expenses associated	
6	with School District Programs .....	5,000,000
7	For payment of expenses associated	
8	with federal programs, including,	
9	but not limited to, construction of	
10	additional beds, treatment programs,	
11	and juvenile supervision .....	2,000,000
12	For payment of expenses associated	
13	with miscellaneous programs, including,	
14	but not limited to, medical costs,	
15	food expenditures, and various	
16	construction costs .....	<u>2,500,000</u>
17	Total	\$9,500,000

18 Section 35. The sum of \$489,800, or so much thereof as  
 19 may be necessary, is appropriated to the Department of  
 20 Juvenile Justice from the General Revenue Fund for costs and  
 21 expenses associated with payment of statewide  
 22 hospitalization.

23 Section 40. The amount of \$1,250,000, or so much thereof  
 24 as may be necessary, is appropriated from the General Revenue  
 25 Fund to the Department of Juvenile Justice for expenses  
 26 related to frontline staff.

27 Section 99. Effective date. This Act takes effect July 1,  
 28 2006.
