A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Illinois Criminal
9 Justice Information Authority:

25 Section 15. The sum of \$37,000,000, or so much thereof
26 as may be necessary, is appropriated from the Criminal
27 Justice Trust Fund to the Illinois Criminal Justice
28 Information Authority for awards and grants to local units of
29 government and non-profit organizations.

30 Section 20. The sum of \$12,000,000, or so much thereof
31 as may be necessary, is appropriated from the Criminal

1 Justice Trust Fund to the Illinois Criminal Justice
2 Information Authority for awards and grants to state
3 agencies.

4 Section 25. The following named sums, or so much thereof
5 as may be necessary, are appropriated to the Illinois
6 Criminal Justice Information Authority for activities
7 undertaken in support of federal assistance programs
8 administered by units of state and local government and non-
9 profit organizations:

14 Section 30. The following named amounts, or so much
15 thereof as may be necessary, are appropriated to the Illinois
16 Criminal Justice Information Authority for awards and grants
17 and other monies received from federal agencies, from other
18 units of government, and from private/not-for-profit
19 organizations for activities undertaken in support of
20 investigating issues in criminal justice and for undertaking
21 other criminal justice information projects:

27 Section 35. The following named amounts, or so much
28 thereof as may be necessary, respectively, for the objects
29 and purposes hereinafter named, are appropriated to the
30 Illinois Criminal Justice Information Authority for awards,
31 grants and operational support to implement the Motor Vehicle

16 Section 40. The sum of \$40,000,000, or so much thereof
 17 as may be necessary, is appropriated from the Criminal
 18 Justice Trust Fund to the Illinois Criminal Justice
 19 Information Authority for awards and grants to state agencies
 20 and units of local government, to include operational
 21 activities and programs undertaken by the Authority, in
 22 support of Federal Crime Bill Initiatives.

23 Section 45. The sum of \$12,440,000, or so much thereof
 24 as may be necessary, is appropriated from the Juvenile
 25 Accountability Incentive Block Grant Trust Fund to the
 26 Illinois Criminal Justice Information Authority for awards
 27 and grants to state agencies and units of local government,
 28 including operational expenses of the Authority in support of
 29 the Juvenile Accountability Incentive Block Grant program.

30 Section 99. Effective date. This Act takes effect July 1,
 31 2006.
