2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Eminent Domain Act is amended by changing 5 the heading of Part 5 of Article 25 and by adding Section 6 25-5-5 as follows:

Quick-take 13 14 proceedings under Article 20 may be used for a period of no more than one year after the effective date of this amendatory 15 Act of the 94th General Assembly by the Indian Prairie 16 Community Unit School District No. 204, DuPage and Will 17 18 Counties, for the acquisition of the following described property for the purpose of school construction: 19

THE WEST 1357.35 FEET, AS MEASURED PERPENDICULAR TO THE 20 WEST LINE THEREOF, OF THE SOUTHEAST 1/4 (EXCEPT THAT 21 PORTION DEEDED TO THE BOARD OF EDUCATION OF INDIAN PRAIRIE 22 COMMUNITY UNIT SCHOOL DISTRICT NO. 204 ON MAY 31, 2005 AND 23 RECORDED JUNE 22, 2005 AS DOCUMENT R2005-130831) AND 24 (EXCEPT THE NORTH 100 FEET THEREOF AND EXCEPT THAT PART 25 CONDEMNED BY CASES 80ED-09 AND 95ED-05) OF SECTION 28, 26 TOWNSHIP 38 NORTH, RANGE 9, EAST OF THE THIRD PRINCIPAL 27 MERIDIAN, IN DUPAGE COUNTY, ILLINOIS, CONTAINING 55 ACRES, 28 29 MORE OR LESS.
