17 WHEREAS, Mr. Klukis was a volunteer firefighter in 18 Warrensburg from 1970 to 1979 before moving to Bethany and 19 joining the Bethany Fire Department; since 1980, he served the 20 Bethany community as a firefighter, Assistant Fire Chief, and 21 most recently, as the Fire Chief; he had taught Certified 22 Firefighter and Certified EMT classes as well as fire 23 prevention; and
