WHEREAS, In 1983, he moved on to the position of associate director of Institutional Research and Planning, and in 1993, he took over the duties of director of the same department; in this position, he was responsible for the overall supervision of the operation of the office, including directing special studies and projects for the President and Board of Trustees of the university; and

WHEREAS, Throughout his years at WIU, he has also served as an associate professor in the Department of Information Management, College of Business and Technology, teaching statistics and research design; he served on many committees
