1 AN ACT concerning local government.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Metropolitan Water Reclamation District Act  
5 is amended by adding Section 297 as follows:

6 (70 ILCS 2605/297 new)

7 Sec. 297. District enlarged. Upon the effective date of  
8 this amendatory Act of the 94th General Assembly, the corporate  
9 limits of the Metropolitan Water Reclamation District are  
10 extended to include within those limits the following described  
11 tracts of land and those tracts are annexed to the District:

12 Parcel 1:

13 BARRINGTON HILLS PARCEL(NORTH): THAT PART OF THE NORTHEAST  
14 QUARTER OF SECTION 33, TOWNSHIP 42 NORTH, RANGE 9 EAST OF  
15 THE THIRD PRINCIPAL MERIDIAN, COOK COUNTY, ILLINOIS,  
16 DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHEAST CORNER OF  
17 THE NORTHEAST QUARTER OF SAID SECTION 33; THENCE SOUTH  
18 89°40'35" WEST ALONG THE NORTH LINE OF SAID NORTHEAST  
19 QUARTER, 2592.78 FEET TO THE EAST LINE OF ILLINOIS ROUTE 59  
20 ACCORDING TO DOCUMENT NUMBER 11194096; THENCE SOUTH  
21 00°11'17" EAST ALONG SAID EAST LINE, 193.36 FEET TO THE  
22 POINT OF BEGINNING; THENCE NORTH 81°58'50" EAST, 221.47  
23 FEET TO A POINT ON A NON-TANGENT CURVE; THENCE SOUTHERLY  
24 ALONG A CURVE CONCAVE WESTERLY HAVING A RADIUS OF 1501.93  
25 FEET WITH AN ARC LENGTH OF 341.98 FEET AND A CHORD BEARING  
26 OF SOUTH 01°29'47" EAST TO A POINT OF NON-TANGENCY; THENCE  
27 NORTH 84°58'24" WEST, 228.14 FEET TO THE EAST LINE OF  
28 ILLINOIS ROUTE 59, AFORESAID; THENCE NORTH 00°11'17" WEST  
29 ALONG SAID EAST LINE, 290.24 FEET TO THE POINT OF  
30 BEGINNING, CONTAINING 1.670 ACRES OF LAND MORE OR LESS.

31 Parcel 2:

32 BARRINGTON HILLS PARCEL(SOUTH): THAT PART OF THE NORTHEAST

1       QUARTER OF SECTION 33, TOWNSHIP 42 NORTH, RANGE 9 EAST OF  
2       THE THIRD PRINCIPAL MERIDIAN, COOK COUNTY, ILLINOIS,  
3       DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHEAST CORNER OF  
4       THE NORTHEAST QUARTER OF SAID SECTION 33; THENCE SOUTH  
5       89°40'35" WEST ALONG THE NORTH LINE OF SAID NORTHEAST  
6       QUARTER, 2592.78 FEET TO THE EAST LINE OF ILLINOIS ROUTE 59  
7       ACCORDING TO DOCUMENT NUMBER 11194096; THENCE SOUTH  
8       00°11'17" EAST ALONG SAID EAST LINE, 1007.47 FEET TO THE  
9       POINT OF BEGINNING; THENCE SOUTH 50°00'12" EAST, 114.07  
10       FEET; THENCE NORTH 62°51'00" EAST, 135.00 FEET TO A POINT  
11       ON A NON-TANGENT CURVE; THENCE SOUTHEASTERLY ALONG A CURVE  
12       CONCAVE NORTHEASTERLY HAVING A RADIUS OF 165.00 FEET WITH  
13       AN ARC LENGTH OF 91.17 FEET AND A CHORD BEARING OF SOUTH  
14       42°58'45" EAST TO A POINT OF NON-TANGENCY; THENCE SOUTH  
15       22°20'04" EAST, 241.05 FEET; THENCE SOUTH 89°51'05" WEST,  
16       176.29 FEET TO THE EAST LINE OF ILLINOIS ROUTE 59,  
17       AFORESAID; THENCE NORTH 00°11'17" WEST ALONG SAID EAST  
18       LINE, 301.00 FEET TO THE POINT OF BEGINNING, CONTAINING  
19       1.356 ACRES OF LAND MORE OR LESS.

20       Section 99. Effective date. This Act takes effect upon  
21       becoming law.
