AN ACT concerning education.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The School Code is amended by changing Section
3-11 as follows:

6 (105 ILCS 5/3-11) (from Ch. 122, par. 3-11)

7 Sec. 3-11. Institutes or inservice training workshops. In counties of less than 2,000,000 inhabitants, the regional 8 superintendent may arrange for or conduct district, regional, 9 10 or county institutes, or equivalent professional educational experiences, not more than 4 days annually. Of those 4 days, 2 11 12 days may be used as a teacher's workshop, when approved by the regional superintendent, up to 2 days may be used for 13 14 conducting parent-teacher conferences or up to 2 days may be 15 utilized as parental institute days as provided in Section 10-22.18d. A school district may use one of its 4 institute 16 17 days on the last day of the school term. "Institute" or "Professional educational experiences" means any educational 18 19 gathering, demonstration of methods of instruction, visitation 20 of schools or other institutions or facilities, or sexual abuse and sexual assault awareness seminar, or training in First Aid 21 (which may include cardiopulmonary resuscitation or 22 23 defibrillator training) held or approved by the regional superintendent and declared by him to be an institute day, or 24 25 parent-teacher conferences. With the concurrence of the State 26 Superintendent of Education, he or she may employ such 27 assistance as is necessary to conduct the institute. Two or 28 more adjoining counties may jointly hold an institute. Institute instruction shall be free to holders of certificates 29 30 good in the county or counties holding the institute, and to those who have paid an examination fee and failed to receive a 31 32 certificate.

1 In counties of 2,000,000 or more inhabitants, the regional 2 superintendent may arrange for or conduct district, regional, county inservice training workshops, or equivalent 3 or professional educational experiences, not more than 4 days 4 5 annually. Of those 4 days, 2 days may be used for conducting 6 parent-teacher conferences and up to 2 days may be utilized as parental institute days as provided in Section 10-22.18d. A 7 8 school district may use one of those 4 days on the last day of school Workshops" 9 the term. "Inservice Training or 10 "Professional educational experiences" means any educational gathering, demonstration of methods of instruction, visitation 11 12 of schools or other institutions or facilities, or sexual abuse 13 and sexual assault awareness seminar, or training in First Aid (which may include cardiopulmonary resuscitation or 14 15 <u>defibrillator training</u>) held or approved by the regional superintendent and declared by him to be an inservice training 16 17 workshop, or parent-teacher conferences. With the concurrence of the State Superintendent of Education, he may employ such 18 19 assistance as is necessary to conduct the inservice training workshop. With the approval of the regional superintendent, 2 20 or more adjoining districts may jointly hold an inservice 21 22 training workshop. In addition, with the approval of the 23 regional superintendent, one district may conduct its own 24 inservice training workshop with subject matter consultants requested from the county, State or any State institution of 25 26 higher learning.

27 Such teachers institutes as referred to in this Section may 28 be held on consecutive or separate days at the option of the 29 regional superintendent having jurisdiction thereof.

30 Whenever reference is made in this Act to "teachers 31 institute", it shall be construed to include the inservice 32 training workshops or equivalent professional educational 33 experiences provided for in this Section.

Any institute advisory committee existing on April 1, 1995, is dissolved and the duties and responsibilities of the institute advisory committee are assumed by the regional office SB0058 Enrolled

1 of education advisory board.

2 Districts providing inservice training programs shall 3 constitute inservice committees, 1/2 of which shall be 4 teachers, 1/4 school service personnel and 1/4 administrators 5 to establish program content and schedules.

6 The teachers institutes shall include teacher training 7 committed to peer counseling programs and other anti-violence 8 and conflict resolution programs, including without limitation 9 programs for preventing at risk students from committing 10 violent acts.
