# 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Public Utilities Act is amended by changing
Section 16-101A as follows:

The The citizens and businesses of the State of 8 (a) Illinois have been well-served by a comprehensive electrical 9 utility system which has provided safe, reliable, 10 and affordable service. The electrical utility system in the State 11 of Illinois has historically been subject to State and federal 12 regulation, aimed at assuring the citizens and businesses of 13 14 the State of safe, reliable, and affordable service, while at 15 the same time assuring the utility system of a return on its investment. 16

17 (b) Competitive forces are affecting the market for 18 electricity as a result of recent federal regulatory and 19 statutory changes and the activities of other states. 20 Competition in the electric services market may create opportunities for new products and services for customers and 21 22 lower costs for users of electricity. Long-standing regulatory 23 relationships need to be altered to accommodate the competition that could fundamentally alter the structure of the electric 24 25 services market.

(c) With the advent of increasing competition in this industry, the State has a continued interest in assuring that the safety, reliability, and affordability of electrical power is not sacrificed to competitive pressures, and to that end, intends to implement safeguards to assure that the industry continues to operate the electrical system in a manner that will serve the public's interest. 1 framework, the industry has been encouraged to undertake 2 certain investments in its physical plant and personnel to 3 enhance its efficient operation, the cost of which it has been 4 permitted to pass on to consumers. The State has an interest in 5 providing the existing utilities a reasonable opportunity to 6 obtain a return on certain investments on which they depended in undertaking those commitments in the first instance while, 7 8 at the same time, not permitting new entrants into the industry 9 to take unreasonable advantage of the investments made by the 10 formerly regulated industry.

(d) A competitive wholesale and retail market must benefit 11 12 all Illinois citizens. The Illinois Commerce Commission should act to promote the development of an effectively competitive 13 electricity market that operates efficiently and is equitable 14 15 to all consumers. Consumer protections must be in place to 16 ensure that all customers continue to receive safe, reliable, 17 affordable, and environmentally safe electric service.

(e) All consumers must benefit in an equitable and timely 18 19 fashion from the lower costs for electricity that result from 20 retail and wholesale competition and receive sufficient information to make informed choices among suppliers and 21 services. The use of renewable resources and energy efficiency 22 23 resources should be encouraged in competitive markets. 24
