

94TH GENERAL ASSEMBLY State of Illinois 2005 and 2006 SB0302

Introduced 2/15/2005, by Sen. Antonio Munoz

SYNOPSIS AS INTRODUCED:

625 ILCS 5/7-316.1 new

Amends the Illinois Vehicle Code. Provides that any nonresident or former Illinois resident who has met all requirements for restoration of driving or registration privileges under the Safety and Financial Responsibility Law of the Code except filing proof of financial responsibility, or any nonresident or former Illinois resident whose license was revoked and who has met all the requirements for applying for driving privileges except filing proof of financial responsibility, shall be released from the Illinois proof of financial responsibility requirement if he or she resides outside of Illinois and has applied for a license in another state. Requires proof of nonresidency. Provides for reimposition of the requirement if the person returns to Illinois within 3 years and cannot show proof of insurance during the period of nonresidency. Provides that the Secretary of State shall adopt rules for implementing the new provision.

1 AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Vehicle Code is amended by adding Section 7-316.1 as follows:
- 6 (625 ILCS 5/7-316.1 new)
- Sec. 7-316.1. Nonresidents and former residents; when proof not required.
- (a) Any nonresident or former Illinois resident who (i) has 9 met all requirements for reinstatement of his or her driving or 10 registration privileges under this Chapter except for filing 11 proof of financial responsibility, (ii) resides outside of 12 Illinois, and (iii) has applied for a driver's license in 13 another state, shall be released from the requirement of 14 15 showing proof of financial responsibility in this State if he or she presents to the Secretary of State, in a manner 16
- 17 <u>satisfactory</u> to the Secretary, notice of his or her
- 18 <u>out-of-state residency.</u>
- 19 <u>(b) Any nonresident or former Illinois resident whose</u>
 20 <u>driver's license was revoked and who (i) has met all</u>
 21 requirements for applying for driving privileges except for
- 22 filing proof of financial responsibility under this Chapter,
- 23 <u>(ii)</u> resides outside of Illinois, and (iii) has applied for a
- 24 <u>driver's license in another state, shall be released from the</u>
- requirement of showing proof of financial responsibility in this State if he or she presents to the Secretary of State, in
- this State if he or she presents to the Secretary of State, in
- 27 <u>a manner satisfactory to the Secretary</u>, notice of his or her
- 28 <u>out-of-state residency.</u>
- 29 <u>(c) If a nonresident or former Illinois resident released</u>
- from the requirement of showing proof of financial
- 31 responsibility in this State under subsection (a) or subsection
- 32 (b) of this Section moves or returns to this State within 3

1	years of the date of release, that person must present to the
2	Secretary of State, in a manner satisfactory to the Secretary,
3	proof of insurance coverage during the period in which the
4	person lived outside of Illinois. A person who fails to present
5	the required proof may not be issued a driver's license until
6	he or she presents proof of financial responsibility that is
7	satisfactory under this Chapter. The proof of financial
8	responsibility required under this subsection (c) must be shown
9	or maintained for the period of time required under this
10	Chapter.
11	(d) The Secretary shall adopt rules for implementing this
12	Section.
