1 AN ACT making appropriations and reappropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4	Section 5. The following named amounts, or so much
5	thereof as may be necessary, for the purposes hereinafter
6	named, are appropriated from the General Revenue Fund to the
7	Board of Trustees of Eastern Illinois University to meet the
8	ordinary and contingent expenses of the University, including
9	payment or reimbursement to the University for personal
10	services and related costs incurred during the fiscal year
11	ending June 30, 2006 and for salaries, commodities,
12	contractual services, equipment, and telecommunications
13	accrued during fiscal year 2005 but remaining unpaid on June
14	30, 2005:
15	Personnel Services\$45,357,200
16	Contractual Services
17	Commodities500,000
18	Equipment500,000
19	Telecommunications
20	Total \$48,357,200

22	Section 10. The sum of \$393,294, or so much thereof as
23	may be necessary and remains unexpended at the close of
24	business on June 30, 2005, from a reappropriation heretofore
25	made for such purpose in Article 106, Section 20 of Public
26	Act 93-842, is reappropriated from the Capital Development
27	Fund to the Board of Trustees of Eastern Illinois University
28	to purchase equipment for the renovation and expansion of
29	Booth Library. No contract shall be entered into or
30	obligation incurred for any expenditure from the

appropriation made in this Section until after the purposes

and amounts have been approved in writing by the Governor.

Section 15. The sum of \$1,500,000, or so much thereof as 2 may be necessary and remains unexpended at the close of 3 business on June 30, 2005, from a reappropriation heretofore made for such purpose in Article 106, Section 15 of Public 5 6 Act 93-842, is reappropriated from the Capital Development 7 Fund to the Board of Trustees of Eastern Illinois University to purchase equipment for the renovation and expansion of the 8 Fine Arts Center. No contract shall be entered into or 9 obligation incurred for any expenditure from 10 appropriation made in this Section until after the purposes 11 and amounts have been approved in writing by the Governor. 12

Section 20. The sum of \$2,000, or so much thereof as may 14 be necessary, is appropriated from the State College and 15 University Trust Fund to the Board of Trustees of Eastern 16 Illinois University for scholarship grant awards, 17 accordance with Public Act 91-83. No contract shall be 18 entered into or obligation incurred for any expenditure from 19 the appropriation made in this Section until after the 20 purposes and amounts have been approved in writing by the 21 22 Governor.

23 Section 99. Effective date. This Act takes effect July 1, 24 2005.
