1 AN ACT concerning regulation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly: 3

- Section 5. The Limited Health Service Organization Act is 4 5 amended by changing Section 2005 as follows:
- (215 ILCS 130/2005) (from Ch. 73, par. 1502-5) 6
- 7 Sec. 2005. Claims Liabilities. (a) Every limited health service organization shall, at all times, maintain liabilities 8 in an amount estimated in the the aggregate to provide for the payment of all claims incurred and any due and unpaid provider capitation, whether reported or unreported, which are unpaid and for which such organization is or may be liable, and to 12 provide for the expense of adjustment or settlement of such 13 claims. Such liabilities shall be computed in accordance with 15 regulations promulgated by the Director upon reasonable consideration of the ascertained experience and character of 16 17 such business for the purpose of adequately protecting enrollees and securing the solvency of such organizations.
 - (b) Whenever the claim and claim expense experience of any such organization shows the liabilities calculated accordance with such regulations to be inadequate, the Director may require such organization to maintain additional liabilities.
