1 AN ACT concerning revenue.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Income Tax Act is amended by adding
- 5 Section 216 as follows:
- 6 (35 ILCS 5/216 new)
- 7 Sec. 216. Tax credit for long-term care insurance premiums. 8 For taxable years ending on or after December 31, 2005 and ending on or before December 31, 2009, each individual taxpayer 9 is entitled to a credit against the tax imposed by subsections 10 (a) and (b) of Section 201 in an amount equal to 25% of the 11 premium costs paid by the taxpayer during the taxable year for 12 each qualified long-term care insurance contract, as defined by 13 Section 7702B of the Internal Revenue Code, purchased on or 14 15 after January 1, 2005 that offers coverage to either the taxpayer or to the taxpayer's spouse, parent, or dependent, as 16 17 defined in Section 152 of the Internal Revenue Code. The credit allowed under this Section may not exceed \$100 for each 18 19 qualified long-term care policy or the amount of the taxpayer's liability under this Act, whichever is less. If the amount of 20 21 the credit exceeds the taxpayer's liability under this Act for the year, then the excess may not reduce the taxpayer's 22 23 liability to less than zero and may not be carried forward to apply to the taxpayer's liability for any succeeding year. A 24 taxpayer is not entitled to the credit with respect to amounts 25 26 expended for the same qualified long-term care insurance contract that are claimed by another taxpayer. 27
- 28 Section 99. Effective date. This Act takes effect upon 29 becoming law.
