WHEREAS, She participated in several youth activities at Brown Street Church of God in Christ, including the Sunshine Band, the Puritans, and the choir; she loved gospel music and was an excellent soloist; she was also an active participant in all aspects of the Church of God in Christ at the local, district, state jurisdictional, and national levels; and

WHEREAS, Along with her husband, she founded Prayer Wheel Church of God in Christ in Springfield and East Side Church of God in Christ in Decatur; she was a lifetime member of Prayer Wheel Church of God in Christ, where she served as first lady for over 45 years, the President of the Mothers' Board, and Superintendent of the Sunday School Department; and

WHEREAS, For 13 years, she was the First Assistant Supervisor of Women in the Central Illinois Jurisdiction for the Church of God in Christ, International; for many years, she was a member of the Springfield Women United and served as President of the Pastors' and Ministers' Wives Fellowship of Springfield; she was awarded the Senior Citizen Meritorious Contribution to the Community Award by the National Association for the Advancement for Colored People, Springfield Chapter;
