1 SENATE RESOLUTION WHEREAS, The members of the Senate of the State of Illinois 2 learned with sadness of the death of Charles "Goose" Sullivan 3 4 of Herrin, formerly of Johnston City, on September 28, 2005; 5 and WHEREAS, Charlie was born August 2, 1942 in Cairo to 6 7 Kenneth Lewis and Mary (Clayton) Sullivan; he graduated from Cairo High School in 1960; he married Dorothy Willis of Cape 8 9 Girardeau, Missouri; and 10 WHEREAS, He was an experienced electrician for Sullivan Electric before he was disabled by multiple sclerosis; and 11 12 WHEREAS, "Goose" Sullivan was a renowned champion duck and 13 goose caller, amassing many national and Illinois State awards within the first 15 years after his high school graduation; for 14 15 example, he placed first nationally 7 times in the Coon Squall 16 category and he placed first 15 times in Illinois in several 17 categories, including Champion of Champions; impressively, in national calling contests, "Goose" achieved 18 the National Title of Champion of Champions 4 times; "Goose" 19 was known far and wide as a legendary hunting guide; and 20 21 WHEREAS, Charlie played bass guitar for the popular '60s 22 band 'The Mod's' and enjoyed playing with other members of 'The 23 Mod's', Kyle Lehning, John Steinhouse, Neil Needham, and Donnie 24 Dickerson when they entertained the crowds that came to hear 25 them play; and 26 WHEREAS, While many people were saddened to learn of his death, Charlie's passing also reminded his friends of his 27
