## SENATE RESOLUTION

2 WHEREAS, The members of the Senate of the State of Illinois 3 learned with regret of the death of Carroll A. Johnson of 4 Rushville on Thursday, December 15, 2005; and

5 WHEREAS, He was born on February 11, 1925, in Huntsville 6 Township to Ira "Bert" and Ethel Phelps Johnson; he married 7 Betty McCutchan in 1961 in Plymouth; and

8 WHEREAS, He was a U.S. Navy veteran of World War II, 9 serving from 1943 to 1946 as an electrical mate second class on 10 the USS Roi; he was awarded the victory medal; and

11 WHEREAS, Mr. Johnson graduated from Plymouth High School in 12 1942, attended Gem City College in Quincy, and received a 13 bachelor's degree in math and science from Western Illinois 14 University in 1951 and a master's degree in administration in 15 1964; and

WHEREAS, He was a farmer, raised hogs, and owned Johnson 16 Bros. Trucking in Plymouth for several years; he taught math 17 and physics at Rushville High School from 1951 to 1966, was 18 principal of Rushville High School, and was assistant 19 20 superintendent in 1967 and superintendent from 1967 until his retirement in 1990; he then served as interim superintendent 21 22 with the Plymouth School District and a consultant with 23 Consulting and Research Group; and

24 WHEREAS, He was a member of First United Methodist Church 25 in Rushville, where served as a trustee, usher, and on the 26 parsonage committee; the Plymouth American Legion Post 912; the Western Administrative Round Table; 27 Phi Kappa Delta fraternity; the Educational League of Illinois; the Illinois 28 Association of School Administrators; the Illinois Principals 29 Association; the West Central Illinois Special Education 30
