AMENDMENT TO HOUSE BILL 29

3 everything after the enacting clause with the following:

"Section 5. Upon the conveyance of the property described in Section 20 to the State of Illinois, the Director of Natural Resources shall convey to the Toney Watkins Company by quit claim deed all right, title and interest in and to the following described land in Perry County, Illinois.

All of the South 1/2 of Section 1, except; the NW 1/4 of the SW 9 10 1/4 of Section 1, the area Northeast of Leopard Road and the area East of Panda Bear Road, The South 1/4 of Section 2, All 11 12 of Section 11, All of that part of Section 12; West of Panda Bear Road, All of that Part of Section 13; West of Panda Bear 13 Road, except, the SW 1/4, of the SW 1/4, of Section 13. All of 14 15 Section 14 except; the East 14 acres of the SE 1/4, of the SE 1/4, of Section 14, T.6S., R.4W., of the 3rd P.M., Perry 16

- 1 County, Illinois and containing approximately 2,000 acres.
- 2 More commonly described as that area of Pyramid State Park
- 3 North of Perry County Hwy 4 (Pyatt-Cutler Road) and west of
- 4 Panda Bear Road.
- 5 Section 20. In consideration of the conveyance by the State
- of the property described in Section 5, the Toney Watkins
- 7 Company shall convey to the State by quit claim deed all right,
- 8 title and interest in and to the following described land in
- 9 Perry County, Illinois.
- 10 Part of Section 21, 22, 23, and 26, all of Section 27, and part
- of Section 28, 33, and 34, T.6S., R.2W. of the 3rd P.M., Perry
- 12 County, Illinois and containing approximately 2,000 acres.
- 13 Section 25. Legislative Findings. A determination has been
- 14 made by the Director of Natural Resources that the properties
- to be exchanged pursuant to Section 5 and Section 20 of this
- 16 Act are of equal value, size and attributes, and further that
- 17 development opportunities expected to be facilitated by the
- 18 exchange will result in a minimum private investment of
- 19 \$100,000,000 and approximately 2,500 jobs.
- Section 30. The transfers of property under Section 5 and
- 21 Section 20 of this Act shall be contingent upon the State of

- 1 Illinois and the Toney Watkins Company entering into a contract
- 2 under which the Toney Watkins Company agrees to pay a sum of
- 3 money to the State of Illinois and perform certain activities
- 4 regarding the remediation and restoration of the property to be
- 5 transferred to the State of Illinois.
- 6 Section 40. Upon this Act becoming law, conveyance
- 7 negotiations shall not be initiated by the Director of Natural
- 8 Resources or the Director's designee until (i) the Department
- 9 of Natural Resources is in receipt of a bond in the amount 10%
- of the appraised value of the property to be conveyed and (ii)
- 11 the submission of completed applications for any and all
- 12 assistance being sought from the Department of Commerce and
- 13 Economic Opportunity, the Illinois Finance Authority, and any
- other federal, State, or local government agencies.
- 15 Section 50. The Director of Natural Resources shall obtain
- 16 a certified copy of the portion of this Act containing the
- 17 title, the enacting clause, the effective date, and the
- 18 appropriate Section containing the land description of the
- 19 property to be transferred under Section 5 within 60 days after
- 20 the effective date of this Act and shall record the certified
- 21 document in the Recorder's Office in the county in which the
- 22 land is located.
- 23 Section 99. Effective date. This Act takes effect upon

1 becoming law.".
