1 AMENDMENT TO HOUSE BILL 226 2 AMENDMENT NO. . Amend House Bill 226 by replacing everything after the enacting clause with the following: 3 "Section 5. The Motor Fuel Sales Act is amended by changing 4 Section 2 as follows: 5 6 (815 ILCS 365/2) (from Ch. 121 1/2, par. 1502) 7 Sec. 2. Assistance at stations with self-service and 8 full-service islands. (a) Any attendant on duty at a gasoline station or service 9 10 station offering to the public retail sales of motor fuel at 11 both self-service and full-service islands described in 12 Section 1 shall, upon request, dispense motor fuel for the 13 driver of a car which is parked at a self-service island and displays: (1) (a) registration plates issued to a physically 14 15 disabled person pursuant to Section 3-616 of the Illinois

Vehicle Code; or (2) (b) registration plates issued to a

1	disabled veteran pursuant to Section 3-609 of such Code; or $\underline{\text{(3)}}$
2	(c) a special decal or device issued pursuant to Section
3	11-1301.2 of such Code; and shall only charge such driver
4	prices as offered to the general public for motor fuel
5	dispensed at the self-service island. However, such attendant
6	shall not be required to perform other services which are
7	offered at the full-service island.

- (b) Gasoline stations and service stations in this State are subject to the federal Americans with Disabilities Act and must:
 - (1) provide refueling assistance upon the request of an individual with a disability; (A gasoline station or service station is not required to provide such service at any time that it is operating on a remote control basis with a single employee, but is encouraged to do so, if feasible.)
 - (2) let patrons know, through appropriate signs, that customers with disabilities can obtain refueling assistance by either honking or otherwise signaling an employee; and
- 21 (3) provide the refueling assistance without any 22 charge beyond the self-serve price.
 - (c) The signage required under paragraph (2) of subsection (b) shall be designated by the station owner and shall be posted in a prominently visible place. The sign shall be clearly visible to customers.

1	(d) The Secretary of State shall provide to persons with
2	disabilities information regarding the availability of
3	refueling assistance under this Section by the following
4	methods:
5	(1) by posting information about that availability on
6	the Secretary of State's Internet website, along with a
7	link to the Department of Human Services website; and
8	(2) by publishing a brochure containing information
9	about that availability, which shall be made available at
10	all Secretary of State offices throughout the State.
11	(e) The Department of Human Services shall post on its
12	Internet website information regarding the availability of
13	refueling assistance for persons with disabilities and the
14	addresses and telephone numbers of all gasoline and service
15	stations in Illinois.
16	(f) A person commits a Class C misdemeanor if he or she
17	telephones a gasoline station or service station to request
18	refueling assistance and he or she:
19	(1) is not actually physically present at the gasoline
20	or service station; or
21	(2) is physically present at the gasoline or service
22	station but does not actually require refueling
23	assistance.
24	(g) The Department of Transportation shall work in
25	cooperation with appropriate representatives of gasoline and
26	service station trade associations and the petroleum industry

- interstate highways in this State with regard to the 2
- availability of refueling assistance for persons with 3
- 4 <u>disabilities.</u>
