and liquor store sting operations.

- (1) Whenever an individual is sentenced for an offense based upon an arrest for a violation of subsection (a) or a similar provision of a local ordinance, and the professional evaluation recommends remedial or rehabilitative treatment or education, neither the treatment nor the education shall be the sole disposition and either or both may be imposed only in conjunction with another disposition. The court shall monitor compliance with remedial education any or treatment. recommendations contained in the professional evaluation. Programs conducting alcohol or other drug evaluation or remedial education must be licensed by the Department of Human Services. If the individual is not a resident of Illinois, however, the court may accept an alcohol or other drug evaluation or remedial education program in the individual's state of residence. Programs providing treatment must be licensed under existing applicable alcoholism and drug treatment licensure standards.
- (m) In addition to any other fine or penalty required by law, an individual convicted of a violation of subsection (a), Section 5-7 of the Snowmobile Registration and Safety Act, Section 5-16 of the Boat Registration and Safety Act, or a similar provision, whose operation of a motor vehicle, snowmobile, or watercraft while in violation of subsection (a), Section 5-7 of the Snowmobile Registration and Safety Act, Section 5-16 of the Boat Registration and Safety Act, or a

- 1 similar provision proximately caused an incident resulting in
- 2 an appropriate emergency response, shall be required to make
- 3 restitution to a public agency for the costs of that emergency
- 4 response. The restitution may not exceed \$1,000 per public
- 5 agency for each emergency response. As used in this subsection
- 6 (m), "emergency response" means any incident requiring a
- 7 response by a police officer, a firefighter carried on the
- 8 rolls of a regularly constituted fire department, or an
- 9 ambulance.
