SYNOPSIS AS INTRODUCED:

720 ILCS 5/25-1.1

Amends the Criminal Code of 1961. Provides that a person commits the offense of unlawful contact with streetgang members when he or she knowingly has direct or indirect contact with a streetgang member after having been ordered by a judge in any non-criminal proceeding to refrain from direct or indirect contact with a streetgang member or members or after having been released from the Illinois Department of Corrections on a condition of parole or mandatory supervised release that he or she refrain from direct or indirect contact with a streetgang member or members.

AN ACT concerning criminal law.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Criminal Code of 1961 is amended by changing
Section 25-1.1 as follows:

6 (720 ILCS 5/25-1.1)

Sec. 25-1.1. Unlawful contact with streetgang members.

8 (a) A person commits the offense of unlawful contact with9 streetgang members when:

(1) He or she knowingly has direct or indirect contact
with a streetgang member as defined in Section 10 of the
Illinois Streetgang Terrorism Omnibus Prevention Act after
having been sentenced to probation, conditional discharge,
or supervision for a criminal offense with a condition of
such sentence being to refrain from direct or indirect
contact with a streetgang member or members; or

17 (2) He or she knowingly has direct or indirect contact 18 with a streetgang member as defined in Section 10 of the 19 Illinois Streetgang Terrorism Omnibus Prevention Act after 20 having been released on bond for any criminal offense with 21 a condition of such bond being to refrain from direct or 22 indirect contact with a streetgang member or members;-

(3) He or she knowingly has direct or indirect contact

1 with a streetgang member as defined in Section 10 of the 2 Illinois Streetgang Terrorism Omnibus Prevention Act after 3 having been ordered by a judge in any non-criminal 4 proceeding to refrain from direct or indirect contact with 5 a streetgang member or members; or

6 <u>(4) He or she knowingly has direct or indirect contact</u> 7 <u>with a streetgang member as defined in Section 10 of the</u> 8 <u>Streetgang Terrorism Omnibus Prevention Act after having</u> 9 <u>been released from the Illinois Department of Corrections</u> 10 <u>on a condition of parole or mandatory supervised release</u> 11 <u>that he or she refrain from direct or indirect contact with</u> 12 <u>a streetgang member or members.</u>

13 (b) Unlawful contact with streetgang members is a Class A 14 misdemeanor.

15 (c) This Section does not apply to a person when the only 16 streetgang member or members he or she is with is a family or 17 household member or members as defined in paragraph (3) of 18 Section 112A-3 of the Code of Criminal Procedure of 1963 and 19 the streetgang members are not engaged in any streetgang 20 related activity.
