SYNOPSIS AS INTRODUCED:

20 ILCS 1605/2 from Ch. 120, par. 1152 20 ILCS 1605/20 from Ch. 120, par. 1170 20 ILCS 1605/21.7 new 30 ILCS 105/5.675 new

Amends the Illinois Lottery Law. Requires the Department of Revenue to offer a special instant scratch-off game, named scratch-out multiple sclerosis, to commence on July 1, 2008. Provides that the net revenue from the scratch-off game shall be deposited into the Multiple Sclerosis Research Fund for appropriation by the General Assembly to organizations in Illinois conducting research pertaining to multiple sclerosis. Sets forth certain provisions for the operation of the scratch-off game. Amends the State Finance Act to create the Multiple Sclerosis Research Fund. Effective immediately.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The Illinois Lottery Law is amended by changing
- 5 Sections 2 and 20 and by adding Section 21.7 as follows:

- 7 Sec. 2. This Act is enacted to implement and establish
- 8 within the State a lottery to be operated by the State, the
- 9 entire net proceeds of which are to be used for the support of
- 10 the State's Common School Fund, except as provided in Sections
- 11 21.2, and 21.5, and 21.6, and 21.7.

- 15 Sec. 20. State Lottery Fund.
- 16 (a) There is created in the State Treasury a special fund
- 17 to be known as the "State Lottery Fund". Such fund shall
- 18 consist of all revenues received from (1) the sale of lottery
- 19 tickets or shares, (net of commissions, fees representing those
- 20 expenses that are directly proportionate to the sale of tickets
- or shares at the agent location, and prizes of less than \$600
- 22 which have been validly paid at the agent level), (2)

- 1 application fees, and (3) all other sources including moneys
- 2 credited or transferred thereto from any other fund or source
- 3 pursuant to law. Interest earnings of the State Lottery Fund
- 4 shall be credited to the Common School Fund.
- 5 (b) The receipt and distribution of moneys under Section
- 6 21.5 of this Act shall be in accordance with Section 21.5.
- 7 (c) (b) The receipt and distribution of moneys under
- 8 Section 21.6 of this Act shall be in accordance with Section
- 9 21.6.
- 10 (d) The receipt and distribution of moneys under Section
- 11 21.7 of this Act shall be in accordance with Section 21.7.

- 15 Sec. 21.7. Scratch-out Multiple Sclerosis scratch-off
- 16 game.
- 17 (a) The Department shall offer a special instant
- 18 scratch-off game for the benefit of research pertaining to
- 19 multiple sclerosis. The game shall commence on July 1, 2008 or
- 20 as soon thereafter, in the discretion of the Director, as is
- 21 reasonably practical. The operation of the game shall be
- 22 governed by this Act and any rules adopted by the Department.
- 23 If any provision of this Section is inconsistent with any other
- 24 provision of this Act, then this Section governs.
- 25 <u>(b) The Multiple Sclerosis Research Fund</u> is created as a

- 1 special fund in the State treasury. The net revenue from the
- 2 scratch-out multiple sclerosis scratch-off game created under
- 3 this Section shall be deposited into the Fund for appropriation
- 4 by the General Assembly to organizations in Illinois conducting
- 5 research pertaining to multiple sclerosis.
- 6 Moneys received for the purposes of this Section,
- 7 including, without limitation, net revenue from the special
- 8 instant scratch-off game and from gifts, grants, and awards
- 9 <u>from any public or private entity, must be deposited into the</u>
- 10 Fund. Any interest earned on moneys in the Fund must be
- deposited into the Fund. For purposes of this subsection, "net
- 12 revenue" means the total amount for which tickets have been
- sold less the sum of the amount paid out in the prizes and the
- 14 actual administrative expenses of the Department solely
- 15 related to the scratch-off game under this Section.
- 16 (c) During the time that tickets are sold for the
- 17 <u>scratch-out multiple sclerosis scratch-off game, the</u>
- 18 Department shall not unreasonably diminish the efforts devoted
- 19 to marketing any other instant scratch-off lottery game.
- 20 (d) The Department may adopt any rules necessary to
- 21 implement and administer the provisions of this Section.
- Section 10. The State Finance Act is amended by adding
- 23 Section 5.675 as follows:
- 24 (30 ILCS 105/5.675 new)

- Sec. 5.675. The Multiple Sclerosis Research Fund.
- 2 Section 99. Effective date. This Act takes effect upon
- 3 becoming law.
