1 Commencing at the northwest corner of Lakewood Creek West -2 Unit 2, being a subdivision of part of the North Half of said Section 2, according to the plat thereof recorded August 15, 3 4 2003, as Document No. 200300028799; thence on an assumed 5 bearing of North 89 degrees 29 minutes 55 seconds West, 575.00 6 feet along the southerly right-of-way line of U.S. Route 30 per Document No. 116443 to the Point of Beginning of Access Control 7 8 to be released; thence continuing North 89 degrees 29 minutes 9 55 seconds West, 70.00 feet along said southerly right-of-way 10 line to the end of said Access Control Release.

Section 160.
