1 AN ACT concerning education.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Southern Illinois University Management Act
is amended by changing Section 8 as follows:

6 (110 ILCS 520/8) (from Ch. 144, par. 658)

Sec. 8. Powers and Duties of the Board. The Board shallhave power and it shall be its duty:

9 1. To make rules, regulations and by-laws, not 10 inconsistent with law, for the government and management of 11 Southern Illinois University and its branches;

12 2. To employ, and, for good cause, to remove a 13 president of Southern Illinois University, and all 14 deans, professors, associate professors, necessarv assistant professors, instructors, and other educational 15 16 and administrative assistants, and all other necessary 17 employees, and contract with them upon matters relating to tenure, salaries and retirement benefits in accordance 18 19 with the State Universities Civil Service Act; the Board 20 shall, upon the written request of an employee of Southern 21 Illinois University, withhold from the compensation of 22 that employee any dues, payments or contributions payable by such employee to any labor organization as defined in 23

the Illinois Educational Labor Relations Act. Under such 1 2 arrangement, an amount shall be withheld from each regular 3 payroll period which is equal to the pro rata share of the annual dues plus any payments or contributions, and the 4 5 Board shall transmit such withholdings to the specified 6 labor organization within 10 working days from the time of 7 the withholding. Whenever the Board establishes a search 8 committee to fill the position of president of Southern 9 Illinois University, there shall be minority 10 representation, including women, on that search committee;

3. To prescribe the course of study to be followed, and
 textbooks and apparatus to be used at Southern Illinois
 University;

4. To issue upon the recommendation of the faculty, diplomas to such persons as have satisfactorily completed the required studies of Southern Illinois University, and confer such professional and literary degrees as are usually conferred by other institutions of like character for similar or equivalent courses of study, or such as the Board may deem appropriate;

To examine into the conditions, management, and 22 administration of Southern Illinois University, to provide 23 requisite buildings, apparatus, the equipment and 24 auxiliary enterprises, and to fix and collect 25 matriculation fees; tuition fees; fees for student 26 activities; fees for student facilities such as student

1 union buildings or field houses or stadium or other 2 recreational facilities; student welfare fees; laboratory 3 fees and similar fees for supplies and material;

6. To succeed to and to administer all trusts, trust
property, and gifts now or hereafter belonging or
pertaining to Southern Illinois University;

7 7. To accept endowments of professorships or 8 departments in the University from any person who may 9 proffer them and, at regular meetings, to prescribe rules 10 and regulations in relation to endowments and declare on 11 what general principles they may be accepted;

12 8. To enter into contracts with the Federal government 13 for providing courses of instruction and other services at 14 Southern Illinois University for persons serving in or with 15 the military or naval forces of the United States, and to 16 provide such courses of instruction and other services;

9. To provide for the receipt and expenditures of Federal funds, paid to the Southern Illinois University by the Federal government for instruction and other services for persons serving in or with the military or naval forces of the United States and to provide for audits of such funds;

10. To appoint, subject to the applicable civil service
law, persons to be members of the Southern Illinois
University Police Department. Members of the Police
Department shall be conservators of the peace and as such

have all powers possessed by policemen in cities, and 1 2 sheriffs, including the power to make arrests on view or 3 warrants of violations of state statutes, university rules and regulations and city or county ordinances, except that 4 5 they may exercise such powers only within counties wherein the university and any of its branches or properties are 6 located when such is required for the protection of 7 8 university properties and interests, and its students and 9 personnel, and otherwise, within such counties, when 10 requested by appropriate State or local law enforcement 11 officials. However, such officers shall have no power to 12 serve and execute civil processes.

13 The Board must authorize to each member of the Southern 14 Illinois University Police Department and to any other 15 employee of Southern Illinois University exercising the 16 powers of a peace officer a distinct badge that, on its 17 face, (i) clearly states that the badge is authorized by Southern Illinois University and (ii) contains a unique 18 19 identifying number. No other badge shall be authorized by 20 Southern Illinois University.

21 (10.5) To conduct health care programs in furtherance 22 of its teaching, research, and public service functions, 23 which shall include without limitation patient and 24 ancillary facilities, institutes, clinics, or offices 25 owned, leased, or purchased through an equity interest by 26 the Board or its appointed designee to carry out such HB2194 Enrolled - 5 - LRB095 01249 NHT 21251 b

activities in the course of or in support of the Board's academic, clinical, and public service responsibilities.

3 11. To administer a plan or plans established by the clinical faculty of the School of Medicine for the billing, 4 5 collection and disbursement of charges made by individual 6 faculty members for professional services performed by 7 them in the course of or in support of the faculty's their 8 academic responsibilities, provided that such plan has 9 been first approved by Board action. All such collections 10 shall be deposited into a special fund or funds 11 administered by the Board from which disbursements may be 12 made according to the provisions of said plan. The incurred, 13 reasonable costs by the University, administering the billing, collection and disbursement 14 15 provisions of a plan shall have first priority for payment 16 before distribution or disbursement for any other purpose. 17 Audited financial statements of the plan or plans must be provided Charges established pursuant to this plan must be 18 19 itemized in any billing and any amounts collected which are 20 not used to off-set the cost of operating or maintaining 21 the activity which generated the funds collected, must be 22 accounted for separately. This accounting must clearly 23 show the use and application made of the funds and the 24 Board shall report such accountings for the previous fiscal 25 year to the Legislative Audit Commission annually by 26 December 31 of each fiscal year.

1 The Board of Trustees may own, operate, or govern, by 2 or through the School of Medicine, a managed care community 3 network established under subsection (b) of Section 5-11 of 4 the Illinois Public Aid Code.

5 12. The Board of Trustees may, directly or in 6 cooperation with other institutions of higher education, 7 acquire by purchase or lease or otherwise, and construct, 8 enlarge, improve, equip, complete, operate, control and 9 manage medical research and high technology parks, 10 together with the necessary lands, buildings, facilities, 11 equipment, and personal property therefor, to encourage 12 and facilitate (a) the location and development of business industry in the State of Illinois, and (b) 13 and the 14 increased application and development of technology and 15 (c) the improvement and development of the State's economy. 16 The Board of Trustees may lease to nonprofit corporations 17 or any part of the land, buildings, facilities, all equipment or other property included in a medical research 18 19 and high technology park upon such terms and conditions as 20 the Board of Trustees may deem advisable and enter into any 21 contract or agreement with such nonprofit corporations as 22 be necessary or suitable for the construction, mav 23 financing, operation and maintenance and management of any 24 such park; and may lease to any person, firm, partnership 25 or corporation, either public or private, any part or all 26 of the land, building, facilities, equipment or other HB2194 Enrolled - 7 - LRB095 01249 NHT 21251 b

property of such park for such purposes and upon such 1 2 rentals, terms and conditions as the Board of Trustees may 3 deem advisable; and may finance all or part of the cost of such park, including the purchase, 4 anv lease, 5 construction, reconstruction, improvement, remodeling, addition to, and extension and maintenance of all or part 6 such high technology park, and all equipment and 7 of 8 furnishings, by legislative appropriations, government 9 grants, contracts, private gifts, loans, receipts from the 10 operation of such high technology park, rentals and similar 11 receipts; and may make its other facilities and services 12 available to tenants or other occupants of any such park at 13 rates which are reasonable and appropriate.

14 The powers of the Board as herein designated are subject to 15 the Board of Higher Education Act.
