1 AN ACT concerning regulation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Limited Health Service Organization Act is amended by changing Section 2005 as follows:
- 6 (215 ILCS 130/2005) (from Ch. 73, par. 1502-5)
- 7 Sec. 2005. Claims Liabilities.
- (a) Every limited health service organization shall, at all 8 9 times, maintain liabilities in an amount estimated in the the aggregate to provide for the payment of all claims incurred and 10 any due and unpaid provider capitation, whether reported or 11 unreported, which are unpaid and for which such organization is 12 or may be liable, and to provide for the expense of adjustment 13 14 or settlement of such claims. Such liabilities shall be computed in accordance with regulations promulgated by the 15 16 Director upon reasonable consideration of the ascertained experience and character of such business for the purpose of 17 adequately protecting enrollees and securing the solvency of 18 19 such organizations.
 - (b) Whenever the claim and claim expense experience of any such organization shows the liabilities calculated in accordance with such regulations to be inadequate, the Director may require such organization to maintain additional
