Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 40. The sum of \$550,000, or so much thereof as may be necessary, is appropriated from the Underground Storage Tank Fund to the Office of the State Fire Marshal for a grant to the City of Chicago for Administrative Costs incurred as a result of the State's Underground Storage Program.
- Section 45. The sum of \$1,000,000, or so much thereof as may be necessary, is appropriated from the Fire Prevention Fund to the Office of the State Fire Marshal for grants available for the development of local government fire prevention.

- 1 Section 50. The sum of \$125,000, or so much thereof as
- may be necessary, is appropriated from the Fire Prevention 2
- Fund to the Office of the State Fire Marshal for grants 3
- available for costs and services related to ILEAS/MABAS
- administration. 5
- 6 Section 55. The sum of \$430,000, or so much thereof as
- may be necessary and remains unexpended at the close of 7
- business on June 30, 2007, from an appropriation heretofore 8
- made for such purpose in Article 65, Section 5 of Public Act 9
- 10 94-0798, is reappropriated from the Fire Prevention Fund to
- the Office of the State Fire Marshal for equipment purchases. 11
- The sum of \$714,200, or so much thereof as 12 Section 60.
- may be necessary, is appropriated from the Fire Prevention 13
- 14 Fund to the Office of the State Fire Marshal for grants
- 15 available for the NITE project.
- Section 99. Effective date. This Act takes effect July 1, 16
